The Montana High School Association (MHSA) and Montana Officials Association (MOA) are excited to announce a new partnership with Arbiter for the 2025-26 school year aimed at streamlining the administration of education-based sports and activities across Montana's high schools.

Beginning in 2025-26, MHSA staff, officials, and member school personnel will leverage Arbiter's comprehensive management software to enhance various operational functions, including:

Required Features

- Officials Registration, Eligibility and Assignment
- Coach Compliance Managing coach information, eligibility, compliance, and clinic requirements, including fundamentals of coaching, concussion in sports, CPR & AED training, and rules clinics.
- MHSA Directory
 - School information
 - Staff entry and contact Information
- Scheduling and Score Entry
- Student Athlete Management (MHSA Included) Allowing the entry of student information into Arbiter, including physical completion dates, graduation year, and other personal details.
- Team Roster: Enabling the entry of team rosters, including heights, weights, jersey numbers, positions, and postseason eligibility.
- Student Transfers: Managing all student transfer and hardship processes via the Arbiter platform.

- Student Registration: Providing full capabilities to create programs, register students, and manage student data.
- Payment Management: Facilitating payments for officials and workers involved in the events.
