

1. A player hits a blind tee shot to an uphill par 3 onto the putting green during a stroke play round. By mistake, the player marks and lifts a ball on the putting green that belongs to another player instead of their own ball. The player replaces that ball, removes the ball marker and holes that putt. The player then tees off on the next hole, what is the ruling assuming there was no serious breach?
 - A. The player has scored a 4 on that hole.
 - B. The player has scored a 5 on that hole.
 - C. The player has scored a 6 on that hole.
 - D. The player is disqualified for playing a wrong ball.

2. A ball in motion that was played from the putting green hits a leaf that is being blown across the putting green. The ball is affected by hitting the leaf and comes up well short of the hole. What is the ruling?
