### REGULAR MEETING Monday, October 9, 2023 HLWW HS Media Center

The Monday, October 9, 2023 Regular School Board meeting of the Howard Lake-Waverly-Winsted ISD #2687 was called to order at 6:32 pm. by Chairperson Heuer.
