- IX.3. Electricity Rates (INFORMATION ONLY)
  Mr. Roberts and Mrs. Sims found a better solution for our electricity. Our average bill has been around \$2500/month and Ameren's rate would have increased us to \$5,325/month.
  The new co-op (Direct Energy) will run around \$3,950/month, which is a savings of \$1,375.
- IX.4. Gas Bills (INFORMATION ONLY)
  Our gas bill doubled (and some) from December to January. A couple of solutions to help would be getting support for a tax waiver on our gas bill and possibly inquiring about a more efficient way to heat the building.
- IX.5. Investment Update (INFORMATION ONLY)
  Mrs. Sims and Mrs. Francis reinvested our CDs at Citizens Bank of Edinburg for 1 year with
  \$1M at 4.5% and \$2M at 4.55% interest; which will increase interest to be earned for a year
  from \$6,689 to approximately \$139,000.
