## Menahga High School Electronic Device Policy (Updated for the 24-25 school year)

### Cell Phones and Other Electronic Communication Devices

Cell phones (including watches that are capable of calling or texting) and other devices are allowed for 9-12th grade students before school, prior to 8:15, between classes, lunchtime, and after the 3:08 bell. For our 7th and 8th grade students, cell phones may only be used before and after school. Cell phones are not allowed during class time or after the tardy bell rings. Teachers may request cell phones to be collected at the beginning of class (basket). If a cell phone is seen or heard during class time, it will be confiscated and turned into the office.

Parents are asked to cooperate with the school in this matter and not text or call their child during class time. If a student needs to make a call in an emergency, they need to report to the office to request permission.

The school principal has the right to regulate electronic device usage. Menahga High School prohibits any member of the school to use electronic devices (including cell phones) to take a picture of a staff member or student for the purpose of displaying it on the internet or in any other public place without the permission of the person photographed. If students take pictures with cell phones or technology, students may be subject to discipline which can include suspension or expulsion. This is a confidentiality issue.

### Electronic Device Violations:

- First Offense: The cell phone will be taken away and returned at the end of the day.
- Second Offense: The cell phone will be taken away, and a parent or guardian must pick it up from the school office.
- Third Offense: The student's cell phone will be turned into the high school office to be locked up daily for the rest of the semester.
- Subsequent offenses will be dealt with by the administration.

Unique Circumstances: Because it is not possible to list every violation that occurs, those not specified will be responded to as necessary by staff on a case-by- case basis. Unique or special circumstances may call for an adjustment in the discipline policies to meet the school's needs.

## ALC INFORMATION

**ALC through Freshwater Education District will be offered after school at the Menahga High School. This is for students who are behind credits and need to make them up in order to graduate. Classes will be held on Tuesdays and/or Thursdays after school depending on student scheduling needs from 3:30-7:00 p.m. Students already enrolled should attend Thursday, September 5th at 3:30. ## Bus Stop Connection



**School time is in the air!!** We and our drivers are excited and looking forward to seeing your student on their bus or van. As bus routes are being planned, **there are expectations** in place to ensure your student is able to take advantage of their riding privilege. Please take a moment to read over these reminders.

Make sure a message can be left on your voicemail in the event you are unable to answer the call. **If you have not received a notice by the end of day Friday, August 30<sup>th</sup>, call the bus garage.**

**STOP** On the bus, students are to do their part in keeping the environment clean. Food is not to be consumed on school buses due to allergies and garbage goes in the trash can.

**STOP** Safety is VERY important! Students are to remain in their seats while the bus is in motion. Also, remember to keep the aisle clear by keeping all body parts within the seat area.

**STOP** Students must acquire a bus pass, from the office, in order to ride a bus they are not assigned to. Passes are only given out for childcare purposes. Parent notes to a driver will not be accepted.
