# Nassau County High School Boys and Girls Bowling League Rules:

- 1. Rosters must be sent to BOCES before the first match is bowled.
- 2. Code of Conduct will remain in effect for the entire season. Each bowler must sign a copy of the code. Coaches are to keep copies on file. Code of conduct will be enforced by respective coaches.
- 3. The lineup will consist of six bowlers per team for each game, using the top 4 scores. The two teams will bowl together with three players from each team on each pair of lanes. Modifications to competition format should be based only on Department of Health & School Board approved guidelines regarding close contact and reported to sport coordinators.
- 4. In the event a team does not have a complete four person lineup for a game, there will be no blind score.
- 5. The scoring will be based on an 11 point system. Three points for each game won, and two points for high team total.
- 6. A bowler may only bowl 3 games during the day of a regular season match. This includes both competition and practice games. Players can participate in one contest per day; therefore, a bowler cannot be substituted between Varsity and JV.
- 7. No team or bowlers may practice prior to competition at the host bowling center on the day of a scheduled match.
- 8. Position Rounds: First position round determined by order of standings. Second round has the exception of having locked positions play each other allowing teams to compete for contested positions in the final standings.
- 9. Ms. Trish Schiller will be our official scorekeeper and will do all the statistics for all conferences. Team and individual scores will be submitted through official format provided by Ms. Schiller. Coaches are responsible for accurate reporting. Winning teams are responsible for reporting match results to Newsday.
- 10. For any other concerns, please refer to the USBC rule book.

### Nassau County High School Bowling Association Rules and Code of Ethics

- 1. Team members MUST wear team uniforms (provided by the school or shirts/sweatshirts of the same color) to participate in any match or tournament.
- 2. Swearing and/or abusive language, obscene gestures and/or abuse of bowling center property will not be tolerated. A bowler will be warned once. A second occurrence will result in automatic removal from the match a zero score will be inserted for the remaining frames of the game.
- 3. Smoking/Vaping will not be permitted during any part of the match (practice and score tabulating included) or inside the confines of the bowling establishment. A bowler found smoking/vaping will be ineligible to participate in the match.
- 4. Intentional fouling (fouling on improbable spares) in order to have a chance to spare will result in removal from the event and loss of pin count in that frame.
- 5. Intentional attempts at distracting bowlers (i.e. gestures, sounds, comments, etc.), while they are in the act of bowling will result in a warning, a second offense will result in removal from the match.
- No hats will be worn when the bowler is competing in a match. (Personal Protective Equipment, medical and religious are the only headgear permitted)
- 7. No electronic devices will be used in the scoring area while competing in a match (i.e. phones, air pods/earbuds, music devices, etc.)

# ENFORCEMENT OF THESE RULES IS THE RESPONSIBILTY OF RESPECTIVE COACHES IN EACH MATCH.

#### **PLAYOFF FORMAT**

County Tournament: Saturday, February 4 th @ Garden City Bowl

Qualifiers: D1(Large Schools): Top 12 teams according to varsity team average.

D2(Small Schools): Top 4 teams according to varsity team average.

Any teams that qualify or feel they may qualify, must have a coach or representative attend the pre-tournament meeting at BOCES or through remote platform on Thursday, February 2<sup>nd</sup> at 8PM.

### Failure to attend this meeting may exclude that team from the tournament.

To determine the county champions, teams will bowl 6 games, <u>6</u> members per game using the top 5 scores. The tournament check-in time is TBD. Teams will bowl three games, followed by a short break to calculate position round. The teams with the highest 6-game total score in each division will be named County Champions.

## PROCEDURES TO DETERMINE THE 6 MALES AND FEMALES THAT WILL REPRESENT THE COUNTY ON THE SECTIONAL TEAMS AT THE STATES:

On February 11<sup>th</sup>, at Garden City Bowl, any male with a <u>200</u> and above average, and females with a <u>160</u> or above average, will compete in a six-game tournament (Please note that there is no rounding up to those averages). In order to qualify, a bowler must have bowled at least <u>18</u> games at the Varsity level during the season. The top 6 male and female bowlers for the six-game competition will represent Section VIII at the State Tournament (one alternate will be named as well). Any members of the county champion teams will be excluded from the competition.

Check-in time will be TBA; bowling will begin at TBA. Tournament format will be three games, followed by a break, with all bowlers returning for three more games.

County Team Tournament: Saturday, February 4th @Garden City Bowl

#### **Oualifiers:**

Division 1 (600+) Schools: Top 12 teams according to varsity team average. Division 2 (<600) Schools: Top 4 teams according to varsity team average.

Check-in time is TBD. Please be on time. Coaches are to check in at the front desk. Lane assignments drawn at playoff meeting will be posted for the first session.

Announcements will begin at TBD, followed by practice.

Bowling begins at TBD.

Six bowlers per team will bowl 3 games in the scheduled round using the top 5 scores each game. Lane rotation may occur if DOH protocols allow. *Please do not move to the next pair until asked to do so*. Lane courtesy should prevail at all times.

The second block of games will begin after the positions have been determined from the first three games. During the break your team may eat lunch at the lanes. Garden City Bowl requests that you do not bring food in from the outside. *Please limit this to coaches only.* 

WE WILL BEGIN THE SECOND SESSION ON TIME; FAILURE TO SHOW UP ON TIME WILL HINDER YOUR TEAM'S CHANCES.

Lane assignments for the Second session will be based on the standings.

You may bring 8 bowlers to the tournament. If you substitute someone in the middle of the game, keep in mind that the sub must be ready to bowl in the designated position. Bowlers that violate the code of conduct and are removed from the game because of the violation *cannot* be substituted for mid-game. Their score at the time of removal becomes their final score for the game.

The team with the highest 6-game total score will be named County Champion. If a tie exists the tie will be broken with a ninth & tenth frame roll-off.

Awards for teams finishing in first and second place; as well as individual high series and high game will be given out at the end of the season awards.

Any protests should be handled during the tournament and reported to Bryan or Eileen immediately.

Scoring/standings will be kept in tournament office/coaches room.

Coaches are to fill out <u>two</u> scorecards in the projected order of your starting lineup – list all bowlers that you will bring to the tournament, last name followed by first name.

After each game, you will record the scores and have the opposing coach double check and initial the results. As soon as possible, coaches are requested to submit their scores to the "coaches room" located behind lanes 3 & 4.

#### NASSAU COUNTY INDIVIDUAL TOURNAMENT INFORMATION

#### ALL BOWLERS MUST HAVE A COACH REPRESENTING THEM AT THE TOURNAMENT!

On Saturday, February 11<sup>th</sup>, the top high school bowlers will compete at Garden City Bowl for the right to represent Nassau County in Syracuse.

The tournament qualifiers will be determined by the following:

Boys: Averages of 200.0 or higher (18 Varsity game minimum)

Girls: Averages of 160.0 or higher (18 Varsity game minimum)

Note: Members of the championship teams will not be eligible since they will be representing their own teams at the states.

Individual bowlers must be accompanied by their coach or school representative the day of the tournament.

Tournament Format: Check-in time is TBA. Bowlers will draw for a lane. There will be 10 minutes of practice. The first three games bowlers will change lanes in a predetermined manner. After 3 games there will be a 20 minute break. The remaining three games, bowlers will be assigned lanes based on their position.

Coaches are responsible for completing scorecards and returning them ASAP to coaches/tournament statistics room.

The top six girls and boys total pin count will represent Nassau County as the Sectional Team at the state tournament.

IT IS THE COACHES RESPONSIBILITY TO MAKE SURE THAT THEIR ELIGIBLE BOWLERS ARE GIVEN THE CORRECT INFORMATION REGARDING THE TOURNAMENT.
