Jr. / Sr. High Principal Ewing reported the following: End of 2nd Semester is tomorrow, Thursday, January 19th with grades due by the beginning of the day Tuesday; Winter Spirit Week is the week of January 23rd - 27th, There will be dress – up days all week and a dance on Saturday, January 28th after the basketball games; All winter sports are just about to head into their final stretch, Boys Basketball has a record of 4 - 8, Girls Basketball has a record of 2 - 12 and Wrestling has a record of 5 - 9 with 1 ranked wrestler in the State's top 10; The Sophomores will be taking the Pre-ACT Test with Ms. Karnitz on Wednesday, March 1st from 8:30 am. – 11:30 a.m.; The Honor Loan Committee will be having their first meeting at the end of January to begin planning for the spring; Will be out of the building for the Minnesota Association of Secondary School Principals Winter Conference from Wednesday, January 25th - Friday, January 27th; Was selected to the MSHSL Representative Assembly by the Region 3 Board for a 2 year term, the group meets once per year in May to vote on MSHSL Policy changes.

This will add 35 instructional minutes, Every 11.5 days on this schedule will make up a day, will make up our current missed days and give us 4 more future snow days, If by April could go back to the original schedule and make up those days; John Rogotzke is installing our bus cameras and stop-arm cameras. It's been a long road for this one; With the board only responsible directly for hiring the superintendent, wanted to let the board know my license has been renewed through 2028; Legislatively, we have hired a lobbyist to push our inflation aid package through, Total cost shared between multiple districts is \$48,000.00, RRC district share of the cost is \$3,500.00; In the governor's budget, universal free meals are a part of it, watching closely, as we have learned, our families who fill out educational benefits (lunch forms) reduced greatly when meals were automatically free; One of the major recommendations is to tie the increase in educational funding to inflation; and City has a chance at a Grant, information presented.

Upon motion of Erickson, seconded by Pankonin and unanimously carried to approve all claims for payment in the amount of \$95,789.60 Final check #30492

Upon motion of Rogotzke, seconded by Pankonin and unanimously carried to accept the offer from Goldschmidt Movers for the shed building reimbursement to include: movers insurance \$125,000 for the building, \$10,000 for cleanup, waiving of the \$44,000 moving fee the shed and concession stand.

Upon motion of Pankonin, seconded by Grant to hire Todd Lee as the Co-Head Golf Coach. Those in favor: Erickson, Grant, Imker, Pankonin and Rogotzke. Those against: Stavnes. Absent: Kuehl. Motion carried.
