## Fillmore Central School Board of Education Regular Meeting April 27, 2021

The regular meeting of the Board of Education for Independent District #2198, Preston, Minnesota was called to order at 6:30 p.m. on the evening of Tuesday, April 27, 2021, in the Fillmore Central Elementary meeting room by Chairman Craig Britton. Present: Superintendent Heath Olstad, Bookkeeper Darla Ebner, Board Members: Bishop, Britton, Pickett, and Topness. Absent: Love, Ristau and Sikkink. Visitors: Daron Omar, Maddie Gasca and Hannah Wingert.

Recognition of visitors: None.

Pickett moved to approve the agenda. Motion was seconded by Bishop. Motion carried unanimously.

Pickett moved to approve the minutes of the March 23, 2021, regular board meeting as presented. Motion seconded by Topness. Motion carried unanimously.

Topness moved to approve the monthly claims in the amount of \$667,746.46. Motion was seconded by Bishop. Motion carried unanimously.

Principal's reports were presented by Heath Olstad.

Member Ristau joined the meeting at 6:36 pm.

Pickett moved to approve an FMLA leave request from Sherry Barr beginning 04/01/21 for a 12-month period on an intermittent basis. Motion seconded by Topness. Motion carried unanimously.

Topness moved to approve the resignation of Jill Eerdmans as K-12 Library/Media Specialist effective 06/04/21. Motion seconded by Bishop. Motion carried unanimously. Thank you to Ms. Eerdmans for her years of service to the Preston-Fountain and Fillmore Central School Districts.

Pickett moved to approve the FMLA leave request submitted by Emily Moger to begin approximately September 26, 2021, for six weeks. Motion seconded by Ristau. Motion carried unanimously.

Member Ristau introduced the following resolution and moved its adoption:

BE IT FURTHER RESOLVED that written notice be sent to said teacher regarding termination and non-renewal of her contract as provided by law, and that said notice shall be in substantially the following form:

You are hereby notified that at the regular meeting of the School Board of Independent School District No. 2198 held on April 27, 2021, a resolution was adopted by a majority vote to terminate your contract effective at the end of the current school year and not to renew your contract for the 2021-2022 school year. Said action of the board is taken pursuant to M.S. 122A.40, Subd. 5.

You may officially request that the school board give its reasons for the non-renewal of your teaching contract. For your information, however, this action is taken due to the financial constraints of the school district and the re-assignment of district personnel.

Ristau moved to approve the hire of Grace Miller as lead teacher in SAC (school-aged childcare). Motion seconded by Topness. Motion carried unanimously.

Motion carried unanimously.

Pickett moved to approve a Memo of Understanding with Luther College for the 2021/22 school year. Motion seconded by Ristau. Motion carried unanimously.

Ristau moved to approve an agreement with ProCare for physical therapy services effective April 8, 2021 to June 3, 2021. Motion seconded by Bishop. Motion carried unanimously.

Topness moved to approve a resolution placing support staff on seasonal leave. Motion seconded by Ristau. Motion carried unanimously.

Ristau moved to rescind prior board action to negotiate with Harmony Transit, Inc. for a two-year transportation contract extension. Motion seconded by Topness. Motion carried unanimously.

Moved by Bishop to seek quotes for bussing services beginning with the 2021/22 school year. Motion seconded by Pickett. Motion carried unanimously.

Moved by Ristau to accept the quote received from Custom Communications for necessary upgrades to the keyless entry system. Motion seconded by Bishop. Motion carried unanimously.

Bishop moved to accept a three-year contract with IEA, Inc. for the 2021/22 to 2023/24 school years. Motion seconded by Topness. Motion carried unanimously.

Topness moved to approve a 2021 high school summer program for 7th and 8th grade students. Motion seconded by Bishop. Motion carried unanimously.

Bishop moved to approve first quarter 2021 donations in the amount of \$28,944.32. Motion seconded by Pickett. Motion carried unanimously. The Board would like to thank the community for their continued support of Fillmore Central Schools.

Ristau moved to approve the request received from Education Minnesota - Fillmore Central to negotiate the 2021-2023 Master Agreement. Motion seconded by Pickett. Motion carried unanimously.

Ristau moved to renew worker's compensation insurance coverage with our current carrier, Accident Fund, for the 2021-22 school year (\$46,077). Motion seconded by Pickett. Motion carried unanimously.

Discussion was held regarding a concessions stand room at the elementary building and a change to the 2020/21end of year calendar.

The May board meeting will be held May 25, 2021 at 6:30 pm at the high school.

Pickett moved to adjourn. Motion was seconded by Topness. Motion carried unanimously.
