Ristau moved to approve the agenda. Motion was seconded by Love. Motion carried unanimously.

Moved by Sikkink to approve the minutes of the November 27, 2018, regular board meeting as presented. Motion seconded by Ellis-Onsager. Motion carried unanimously.

Aaron Hess from A&F Consulting and Superintendent Keith updated the Board on the football field upgrade and high school secure entrance/admin office/cafeteria/media center remodel.

Moved by Sikkink to approve A&F Consulting as the owner's rep for these projects. Motion seconded by Love. Motion carried unanimously.

Principal's report and Dean of Students'/AD reports were presented by Heath Olstad.

Moved by Ristau to approve the hire of Kathy Stafki as SAC assistant for up to 40 hours as needed to replace Emma Breitsprecher during sports activities. Motion seconded by Ellis-Onsager. Motion carried unanimously.

Moved by Love to approve the hire of Walker Ward as assistant wrestling coach. Motion seconded by Ellis-Onsager. Motion carried unanimously.

Moved by Love to set the 2019 Driver Training Fees as follows: \$330.00 for Fillmore Central students, \$380.00 for out-of-district students, and \$40.00 per hour for extra BTW time. Motion was seconded by Ristau. Motion carried unanimously.

Discussion was held regarding handling lawn mowing duties in-house rather than contracting with a lawn care service. It was the consensus of the Board to continue looking into this possibility.
