Moved by Ristau to close the campus at the high school starting with the 2008/09 incoming freshman class and all future freshman classes until their senior year. Motion was seconded by Topness. Motion carried unanimously.

Moved by Stevens to approve the lawn mowing bid from Wintergreen Lawn & Snow Services for district mowing at \$300.00 per time for the 2008 and 2009 mowing seasons. Motion was seconded by Ostrom. Motion carried unanimously.

Ms. Luehmann informed the board of the School Board Election filing dates of July 1, 2008-July 15, 2008.

Britton moved to adjourn. Motion seconded by Stevens. Motion carried unanimously.
