Motion seconded by Sikkink. Motion carried unanimously.

Torgrimson moved to approve adding a 7th and 8th grade advisor to the extra-curricular schedule at \$200.00 each. Motion was seconded by Britton. Motion carried unanimously.

Sikkink moved to approve adding a Flag Corps Advisor to the extra-curricular schedule at \$500.00. Motion was seconded by Britton. Motion carried unanimously.

Sikkink moved to approve changing the summer band pay from 10 days to 120 hours which will include 5th and 6th grade lessons and band camp. Motion was seconded by Torgrimson. Motion carried unanimously.

Superintendent discussed the SSC Board of Directors nominations, MREA and MSBA upcoming meetings, and updated the board on the Jobs Education Bill and Flexible Learning Year Consortium.
