Love moved to approve the agenda with following changes/additions:

Love moved to hire Ms. Sara Niemeyer as elementary teacher (MA, 9). Motion seconded by Ristau. Motion carried unanimously.

Britton moved to hire Mr. Kyle Rundquist as elementary teacher (BA, 1). Motion seconded by Torgrimson. Motion carried unanimously.

Love moved to hire Mr. Jon Haug as part-time custodian (4.5 hours/day). Motion seconded by Britton. Motion carried unanimously.

Love moved to approve tenure for Ms. Mary Beth Armstrong, Mrs. Julie Siebenaler, and Mr. Brian Wolfgram. Motion seconded by Topness. Motion carried unanimously.

Sikkink moved to hire Laurie Hendrickson and Darla Ebner as co-coaches for junior high volleyball for the 2011/12 school year. Motion was seconded by Topness. Motion carried unanimously.

Britton moved to deny the request for Athletic Director summer pay received from Ms. Jane Montgomery. Motion seconded by Topness. Motion carried unanimously.

Moved by Sikkink to adopt the following resolution:

RESOLUTION AUTHORIZING AND AWARDING SALE OF GENERAL OBLIGATION AID ANTICIPATION CERTIFICATES OF INDEBETEDNESS, SERIES 2011B, AND FIXING FORM AND TERMS THEREOF IN CONNECTION WITH THE MINNESOTA TAX AND AID ANTICIPATION BORROWING PROGRAM SPONSORED BY THE MINNESOTA SCHOOL BOARDS ASSOCIATION AND GREATER MINNESOTA SERVICE COOPERATIVES.

Sikkink moved to designate Mr. Richard Keith as local education agency representative and homeless liaison. Motion seconded by Torgrimson. Motion carried unanimously.

Love moved to designate Mr. Chris Mensink as the 504 coordinator for grades K-6. Motion seconded by Sikkink. Motion carried unanimously.

Britton moved to approve the following for the 2011/12 school year:

- Set substitute teacher pay at \$100.00/day; \$50.00/half day
- Set the number of days as a substitute before being placed on the salary schedule at 10 consecutive days
- Set substitute secretary pay at \$8.00 per hour
- Set substitute paraprofessional pay at \$8.00 per hour
- Set substitute custodial pay at \$9.50 per hour
- Set van and substitute van driver at \$8.75 per hour
- Set payroll policy regarding 403b sign-up for employees in September only

Ristau moved to set activity fees, admission fees, and season sports pass prices for the 2011/12 school year as follows:
