Fillmore Central School Board of Education Regular Meeting May 24, 2011

The regular meeting of the Board of Education for Independent District #2198, Preston, Minnesota was called to order at 6:38 p.m. on the evening of Tuesday, May 24, 2011, in the Fillmore Central High School Media Center by Chairperson Kiehne. Sikkink moved to approve the agenda with following changes/additions:

Motion was seconded by Ristau. Motion carried unanimously.

Ristau moved to approve the minutes of the April 26, 2011, regular board meeting. Motion was seconded by Topness. Motion carried unanimously.

Sikkink moved to approve the minutes of the April 27, 2011, special board meeting. Motion was seconded by Britton. Motion carried unanimously.

Ristau moved to approve a two year superintendent contract with Richard Keith for 150 days per year with a salary of \$60,000 for 2011-2012 and \$61,200 for 2012-2013. Motion was seconded by Sikkink. Motion carried unanimously.

Britton moved to approve the hiring of the following volleyball coaches for the 2011-2012 school year: Travis Malley-B Squad and Brenda Ryan-Jr. High. Motion was seconded by Sikkink. Motion carried unanimously

Britton moved to accept the resignation and retirement request from Connie Lindstrom effective at the end of the 2010-11 school year. Motion was seconded by Torgrimson. Motion carried unanimously.

Ristau moved to accept the resignation request from Tara Shanks effective June 30, 2011. Motion was seconded by Britton. Motion carried unanimously.

Torgrimson moved to accept the resignation request from Frank Tribon effective at the end of the 2010-11 school year. Motion was seconded by Britton. Motion carried unanimously.

Sikkink moved to accept the resignation request from Mary Hatfield effective at the end of the 2010-2011 school year. Motion was seconded by Topness. Motion carried unanimously.

Ristau moved to approve the adjusted 2010-2011 school calendar to 174 student days. Motion seconded by Sikkink. Motion carried unanimously.

Britton moved to approve 10 additional days over the summer for the Chris Mensink, Dean of Students, at his contracted daily rate of pay. Motion seconded by Topness. Motion carried unanimously.

Britton moved to approve the following FTE changes for the 2011-2012 school year: Lyndsey Crossley from .25fte to .50fte, Sarah Holten from .8fte to 1.0fte, Marit Janssen from .4fte to 1.0fte, Gerri Himli .2fte at RRP and .8fte at FCES to 1.0fte at FCES. Motion was seconded by Ristau. Motion carried unanimously.

Sikkink moved to approve the administrative budget proposal for the 2011-2012 school year as presented with the conditional savings in transportation. Motion was seconded by Ristau. Motion carried unanimously.

Member Sikkink introduced the following resolution and moved its adoption:

RESOLUTION PLACING DANETTE GRIMSRUD ON UNREQUESTED LEAVE OF ABSENCE

WHEREAS, the School Board of Independent School District No. 2198 adopted a resolution proposing placement of Danette Grimsrud on unrequested leave of absence on May 24, 2011, on the grounds of discontinuance of position, lack of pupils, and financial limitations; and

WHEREAS, said written notice of the proposed placement on unrequested leave was received by Danette Grimsrud by personal service on May 4, 2011, and

WHEREAS, said written notice of the proposed placement on unrequested leave contained a statement setting forth the reasons for the proposed placement as well as a statement that he was entitled to a hearing before the school board provided he make a request in writing within fourteen days of receipt of said notice, and that if no hearing was requested within said fourteen day period it constituted acquiescence by Danette Grimsrud to the school board's proposed action, and

WHEREAS, no written request of any kind was received by the school board or superintendent of schools from Danette Grimsrud for a hearing as of May 19, 2011, and

WHEREAS, said failure to make written request for a hearing within fourteen days after receipt of notice of proposed placement on unrequested leave constitutes acquiescence by Danette Grimsrud to his placement on unrequested leave.

BE IT HEREBY RESOLVED, by the School Board of Independent School District No. 2198 that Danette Grimsrud be and hereby is placed on unrequested leave of absence as a teacher of Independent School District No. 2198 on the grounds of reduction of position, re-configuration of pupils and financial limitations effective at the end of the 2010-2011 school year on June 30, 2011, pursuant to Minnesota Statutes, Sec. 122A.40, Subd. 11, without pay or fringe benefits.

BE IT FURTHER RESOLVED that said placement on unrequested leave of absence is not the result of the implementation of an education district agreement

BE IT FURTHER RESOLVED that a notice of placement on unrequested leave, together with a copy of this resolution be forwarded to said teacher personally and that an affidavit of same be placed in his file together with a copy of the notice and resolution.

The motion for the adoption of the foregoing resolution was duly seconded by Member Britton and upon vote being taken thereon, the following voted in favor thereof:
