Discussion was held regarding terminating the current contract for mental health services with Zumbro Valley Mental Health and hiring a 1.0 FTE Therapist (LPN), a .2 FTE Mental Health Professional (year round), and .2 FTE billing clerk (year round). It was the consensus of the Board to terminate the contract and hire the recommended staff on our own.
