Love moved to approve the agenda. Motion was seconded by Sikkink. Motion carried unanimously.

Member Britton joined the meeting at 6:33 p.m.

Ellis-Onsager moved to approve the minutes of the September 23, 2014, regular board meeting as presented. Motion seconded by Love. Motion carried unanimously.

Sikkink moved to approve the monthly claims in the amount of 1,478,948.62. Motion was seconded by Ristau. Motion carried unanimously.

Dean of Student's report was presented by Chris Mensink.

Principal's report was presented by Heath Olstad.

Britton moved to approve the resignation of Sheldon Stockdale as a custodian. Motion seconded by Love. Motion carried unanimously.

Love moved to approve the hire of Jeffrey Dick as 8th grade boys basketball coach. Motion was seconded by Ellis-Onsager. Motion carried unanimously.

Sikkink moved to approve the hire of Tom Siebenaler as Math Wizards advisor. Motion seconded by Britton. Motion carried unanimously.

Britton moved to approve the hire of Riley Bahl (BA, 1) as 5th grade teacher for the remainder of the 2014/15 school year. Motion seconded by Ellis-Onsager. Motion carried unanimously.

Member Love introduced the following resolution and moved it adoption:
