Moved by Britton to approve the agreement with Stanley Stutzman for Mental Health services as needed when Melissa Simonson is absent for the 2014-15 school year. Motion was seconded by Ellis-Onsager. Motion carried unanimously.

Moved by Sikkink to approve the two graduate credit reimbursement requests and the two salary schedule land change requests per the Master Agreement. Motion was seconded by Love. Motion carried unanimously.

Moved by Love to approve the proposed 2014 Payable 2015 Levy at the maximum amount. Motion was seconded by Britton. Motion carried unanimously.

Moved by Sikkink to advertise for quotes for snow removal for the 2014-2015 and 2015-16 winter seasons and the lawn care for the 2015 and 2016 summers at both the Harmony and Preston sites. Motion was seconded by Love. Motion carried unanimously.

Moved by Britton to seek quotes for a van to replace one that is due to expire in December, 2014. Motion was seconded by Topness. Motion carried unanimously.
