The Community Ed, Elementary/Athletic Director, and High School principal's reports were presented by Heath Olstad.

Love moved to approve the transfer of \$650.00 for elementary supply fee assistance. Motion seconded by Bishop. Motion carried unanimously.

Love moved to approve the open enrollment request received for two students from the Houston School District. Motion seconded by Ristau. Motion carried unanimously.

Discussion was held regarding the need to refinish the high school gym floor and also looking into what the options may be to dehumidify or air condition the stage and classrooms in the older portion of the building.
