## **The MASMS 2020 Conference and Scholarship Golf Event CANCELLED DUE TO COVID 19**

After careful consideration, the MASMS Executive Board has decided to cancel the 2020 MASMS Conference and Trade Show and the Scholarship Golf Event.

We feel that the risks to hold these events are too significant to ignore. We have been monitoring current updates and recommendations from the CDC and the State of Minnesota, and with our large group we could not stay within the recommended guidelines. Along with this is the risk of spreading the coronavirus to our schools and communities, and with a great concern of the health of our members, the final decision to cancel was made with a heavy heart, but also knowing it is the right thing to do.

#### **Reschedule Info**

At this time there are no plans to reschedule the conference. Instead, we are looking at ways to provide additional education and networking opportunities throughout the year at the chapter level.

#### **Refund Info**

Registrations for attendees, exhibitors and sponsors will be refunded. The MASMS office will be contacting those that registered to confirm refund methods.

#### **Hotel Info**

If you are a business member, and made a hotel registration at the Holiday Inn and Suites, please call the hotel to cancel your reservation. The MASMS office cannot do this (as much as we tried), as the rules for the hotel state that reservations must be cancelled by those who made them. Their front desk number is 320-253-9000. If you are an educational member, MASMS will cancel your reservations.

Please know that the MASMS membership year runs from July 1st to June 30th each year, so even with the conference being cancelled, you still need to renew your membership. 


