Educational Opportunity: The 2015 Great Lakes School of Turfgrass Science Online is set for Jan. 7th–March 25th, 2015

This 12-week program will have training sessions accessible live online on Wednesday evenings from 6 to 8pm or the option to view the recorded sessions. This 12-week certificate program aims to provide participants with thorough and practical continuing education in turfgrass management. The course is directed by educators from the University of Minnesota-Twin Cites and the University of Wisconsin-Madison, with 12 turfgrass scientists and educators from eight Land-Grant Universities.

State Fire Marshal Delayed /Staged Fire Evacuation New Policy

The MN State Fire Marshal's Office has updated their Delayed and Staged Evacuation plans for schools.

The State Fire Marshal's Office and Law Enforcement have collaborated regarding the concerns with an intruder entering a building and activating the fire alarm with the purpose of triggering students and staff into common areas and resulting in evacuation of the building when the fire alarm sounds.

Delayed Evacuation: This allows for a predetermined amount of time to allow the designated building staff to investigate the source of the fire alarm prior to evacuation.

<u>Staged Evacuation</u>: This allows for occupants to temporarily relocate to separate rated fire area within the building while the source of the alarm is investigated.

You district's plans for a delayed/staged fire evacuation needs to be developed with coordination of local fire, law enforcement and emergency management agencies along with the assigned State Fire Marshal School inspector. Delayed /Staged plans must be approved by your school administration, school board and the State Fire Marshal Division prior to implementation.

Avoiding Slips, Trips, and Falls this Winter-You may want to share this with school staff!

Winter can often mean periods of icy or snowy weather conditions. While the Facilities Department and buildings staff work

diligently to remove snow and ice from walkways, building entrances, and parking lots, you still may encounter slippery surfaces while on school grounds.

We offer the following safety tips for avoiding slips and falls during this winter season:

- Select appropriate footwear. There is no single shoe sole material that is perfect under all conditions, however, footwear with rubber or neoprene composite soles provided better traction on ice and snow than leather or plastic. Change into dress shoes once you are at work. The inconvenience of changing shoes is insignificant compared to the inconvenience due to a serious fall related injury.
- Think about the best route to your destination and plan a little extra time to get there. Avoid rushing, taking shortcuts over snow piles or traversing areas where snow and ice removal is incomplete.
- If you have no choice but to walk on slippery surfaces, bend slightly forward and shorten your stride or shuffle your feet for better stability. Many slips and falls occur during entry or exit from vehicles. Be particularly careful and hold on to the vehicle for support.

When entering a building be sure to:

- Take advantage of floor mats to remove moisture from the soles of your shoes. This will help protect you, as well, as others who follow, from having to walk on wet or slippery surfaces.
- Avoid walking on wet or slippery areas if possible.

Take responsibility for immediately reporting slip and fall hazards. We encourage you to report slippery conditions in parking lots, walkways and building entrances.

Laugh Bring more laughter into your life. It is a powerful way to improve your attitude.


Pray or Meditate For a couple of minutes every day. You'll be surprised how positive this can be.




