

# **Reclaiming the** Neighborhood

66 D anana Kelly," which refers to the banana-curved Kelly Street in the South Bronx of New York, was probably one of the last neighborhoods anyone wanted to live in. Vacant buildings lined the rubblestrewn streets. The city considered it a hopeless neighborhood and the private sector refused to invest in it. At times people in the neighborhood would have to fill buckets from the fire hydrant because their water lines would get cut off.

Yet Harold DeRienzo had hope for the neighborhood. In fact, as everyone else was moving out, he moved in.

Harold began organizing the neighbors who were left. They learned each other's names and started doing things together. They held street cleanups and block parties, and started planting flowers. Slowly, the neighborhood began to change for the better. 'Banana Kelly needs to be viewed as a vehicle for local empowerment," Harold says. "To retain a sense of community, people have to have a sense that they're affecting their own lives."

# Helpful Hints

Four steps that make neighborhood boundaries easier:

- 1. Get together with other parents on your block. Discuss neighborhood boundaries.
- 2. Find three neighborhood boundaries that everyone agrees on.
- 3. Hold a neighborhood party to report your findings. Get other's reactions.
- 4. Publish the boundaries in a one-page newsletter for everyone in the neighborhood.



What does this have to do with neighborhood boundaries? Everything, When you ask people why they don't take responsibility for monitoring young people's behavior in the neighborhood, they point to fear. They're afraid of the kids. They're afraid of the kids' parents. In essence, they're afraid of their neighbors.

It's easier to have neighborhood boundaries when people perceive their neighborhoods as caring communities. You don't need to be a community organizer to help create a neighborhood where neighbors monitor young people's behavior. All you need to do is to start getting to know the people who live near you. Start with the ones who seem friendly. Get to know the children. Talk with their parents about boundaries they would like for their children in the neighborhood. Then together you can start building this asset.

### Ideas for Neighborhood Boundaries

What are some neighborhood boundaries that you might want to consider?

- · Respect each other's property.
- · Report any suspicious activity.
- Supervise children younger than 16.
- End parties by 11:00 p.m.
- Talk to neighbors directly about concerns.

# **Connect, Then Decide**

Before you decide on appropriate boundaries for your neighborhood, connect with other neighbors to get to know them. Try these simple ideas:

- Hold a front-yard, neighborhood barbecue.
- Organize all the dog owners to take a walk together (with the dogs) once a week.
- Suggest a parent get-together. Ask older youth to supervise and play with the younger children.

- Contact your local police department and ask for help in having a block meeting to discuss safety.

Quick Tip: Notice daily what happens in your neighborhood.

# **Tips for Monitoring**

Once neighbors agree on some common boundaries, encourage each other to:

- Point out boundaries to youth. For example, if a neighbor hears young people swearing, everyone should support the neighbor saying, "We don't use that kind of language in our neighborhood."
- Call other neighbors about concerns or questions. Distribute a neighborhood directory with names, phone numbers, and addresses of neighbors interested in participating.

# City of Hill City Council Meeting January 8, 2018

1. Call to Order/Pledge of Allegiance

A. Mayor Dan Kingsley presided over the meeting and called the meeting to order at 6:00 p.m.

B. Everyone joined in the Pledge of Allegiance.

# 2. Oaths of Office

Clerk McManigle administered the Oaths of Office to new Council members Wayne Lindquist and Nathan Rollins. Mayor Kingsley noted that he had taken the Oath of Office earlier in the day from Clerk McManigle so that there would be a quorum present to open the meeting. Council present: Mayor Dan Kingsley, Council members Terry Christensen, Neal Roettger, Wayne Lindquist and Nate Rollins.

# 3. Consent Agenda

Motion made by Christensen to approve the consent agenda as presented, second by Roettger. MPU (Motion Passed Unanimously).

# 4. Public Forum

Police Chief Kimball had asked to have item D. under Old Business, IBEW Union moved up on the agenda to under Public Forum.

A representative of the IBEW Local 31 Union was present in regard to Police Chief Kimball joining the Union. There was discussion on the Chief of Police joining a Union and the representative answered questions from both the Council and some citizens. Mayor Kingsley said that the Council would take the Chief of Police joining the Union under advisement at this time but they would like to see more of what the actual plan would be.

5. Addition or Corrections to the Agenda Mayor Kingsley had some additions to the agenda. Under New Business, A. 1. Committee Appointments, D. 1. Amend October 16, 2018 minutes, F. I.U.O.E. Union Memorandum of Understanding for a pension increase. Motion made by Rollins to add the additions to the agenda, second by Lindquist. MPU

It was also decided to move Reports to after New Business on the agenda for this meeting only.

# 6. Old Business

A. Detachment from City – Chris Wojciechowski & Joshua Philippi

Chris and Joshua were present at the meeting to see if the Council would approve their detaching their property from the City and into the Township. Mayor Kingsley explained that since there are new Council members that were unaware of this prior request, this will wait until the next meeting so the new Council members have time to investigate this. This was tabled until the next meeting.

# B. Walking Trail

Tom Fasteland had sent information about a grant for trail maintenance that he had wanted forwarded to George

Casper. George Casper said that he had contacted City Engineer Bob Beaver for current pricing on paving, reclaim, gravel, etc. before Christmas and had not heard back from him yet so he would contact him again. This was tabled until the next meeting.

C. Water budget – increase for water tower There was discussion on increasing the water rates to start obtaining funds for the repainting/rehab of the water tower in 2 to 3 years. SEH, City Engineering firm, to be contacted about finding grant funds for this project. Other cities are also to be contacted to find out what their water rates are. The increasing of the water billing will be revisited when the Fee Schedule Ordinance is reviewed.

# 7. New Business

A. Approve Resolution #2019-03, Setting 2019 Appointments

Resolution #2019-03, Setting 2019 Appointments was gone through with the following appointments made: Official Bank Signers: Diana McManigle, Terry Christensen, Daniel Kingsley and Wayne Lindquist, Official Depository: Woodland Bank, Official Newspaper: Grand Rapids Herald Review, Mileage Reimbursement Rate: Federal Rate, Acting Mayor: Terry Christensen, Official City Attorney: Brad Person, Official City Engineer: SEH, Official City Auditor: Justin Clausen & Company. Commissioner Appointments: Public Safety: Terry Christensen, Water/Sewer: Neal Roettger, Streets/ Airport: Nate Rollins, Parks/Recreation: Wayne Lindquist, Administration/Maintenance: Dan Kingsley.

# A. 1. Committee Appointments

Committee Appointments made were: Facilities/ Equipment: Wayne Lindquist and Nate Rollins, Land Use/ Zoning: Terry Christensen and Neal Roettger. Motion made by Rollins to approve Resolution #2019-03, Setting 2019 Appointments as indicated above, excluding the Personnel Committee to be set at a later date, second by Roettger. MPU

B. Approve LG220, Raffle Permit for Hill City Archery Motion made by Rollins to approve a Raffle permit for Hill City Archery, second by Christensen. MPU

C. Haypoint Jackpine Snowmobile Club – relocate snowmobile trail in Hill City

Jim Lamke was present and showed the Council a map of an area of the snowmobile trail that they would like to see relocated within the city that would access more businesses in town and avoid more blacktopped streets. Motion made by Roettger to accept the presented trail change, second by Rollins. Mayor Kingsley abstained, all other members voted in favor. Motion carried.

D. Correction of Council Minutes of 10/16/18 There was a request to amend the Council meeting minutes of the October 16, 2018 minutes. Those amendments were: 1) Under Public Forum: The verbiage "Union Contract" should say "Labor contract negotiations". 2) Under New Business (G): In the 5th paragraph, the verbiage: "the Mayor was the second on the motion" and replace with "the Mayor was one of the original votes". 3) Also let it be noted that the verbiage of "Clerk McManigle checked with the City Attorney the morning of October 17, 2018 and she was correct, because there was a quorum present and the vote was 2-0 the Mayor could appoint whomever he wanted" should not have been in the minutes because this happened the next day and not at the actual Council meeting of October 16, 2018. (All of the above proposed amendments were approved by prior Mayor, Larry Baker).

Motion made by Rollins to change the minutes of October 16, 2018 as stated above, second by Lindquist. Mayor Kingsley abstained, Council member Roettger abstained, Christensen voted yes, Lindquist voted yes and Rollins voted yes. Motion carried.

D. 1. Amendment of Council Minutes of 10/16/18 There was another request to amend item #3 under Public Forum to reflect that Council member Christensen stated: "I guess I have to ask Mr. Kingsley, don't you think we would be remiss in our job if we don't do these contracts the way we are supposed to be doing them". Mr. Kingsley answered: "With that said, yes I do". Motion made by Lindquist to amend item #3 under Public Forum to reflect the above statements, second by Christensen. MPU

E. Set date for Council work session

A Council work session was set for January 15, 2019 at 4:00 p.m. in the Community Room.

F. Memorandum of Understanding with I.U.O.E. The I.U.O.E. needed a Memorandum of Understanding signed that reflected that the City of Hill City will be making a \$.25 per hour contribution to the employees' pension plan as was stated in the Union Contracts. Motion made by Rollins to approve the signing of the Memorandum of Understanding, second by Roettger. MPU

# 8. Reports

Maintenance/Water/Sewer/Parks/Airport/Streets

• George Casper reported that the iron test for Well 2 was higher than can be treated. Since the well had not been ran for quite some time, Casper decided to run the well and then have it retested. We are currently waiting for the results of the latest test.

• The chlorine feed pump went bad and the spare was installed. Checking on getting the original pump repaired.

• Casper and Jordan had cleaned some sewer pumps and discovered that there was an issue with the crane used to pull the pumps. Repair of the crane is being looked into.

• The airport was closed for 5 days over the holiday's because of weather but is now back open.

• There were a few issues with snow being plowed

across roads and also being plowed onto the street rightof-ways. Notices will be put up to remind people not to do this in the future.

• The grader that plows the township roads had caught on fire and was unable to plow the township roads. The city was contacted to plow for Mike Casper and will be charged accordingly.

### **Fire Department**

• Assistant Fire Chief Ron Saxton reported that there had been a lot of calls lately, mostly crashes.

• Cody Fox was appointed EMS Fire Captain.

• Pull tab revenue is down. The bond payment on the Fire Hall addition was made as well as 3 payments back to the city.

#### Police Department

• Police Chief Josh Kimball gave the monthly police report.

• Council member Lindquist asked if the city had a noise ordinance as there was an extremely loud snowmobile that was around at all hours. Chief Kimball to follow-up.

• Mayor Kingsley had asked Chief Kimball for a report on the happenings at Chappy's. Chief Kimball stated that he could not comment at this time because this was an active investigation.

• Mayor Kingsley thanked the public for their support and gave an overview of some of the items he would like to see addressed during his term as Mayor.


### Clerk
