

The Pledge of Allegiance was recited.

Roll Call by clerk showed the following members present: Sue Kaslow, Joell Miranda, Bambi Lange, Mark Meyer, Dorie Barnes and Sarah Kingsley. Board Members absent: None. Also present was Superintendent/Principal Pat Rendle, Business Manager Ellie Hill, Building & Grounds Director Eric Hill and Payroll Clerk/Administrative Secretary Lynn Major.

- 1. Approved the Agenda as Presented.
- The Oath of Office was taken by Joell Miranda, Bambi Lange and Sarah Kingsley with a copy attached to the Minutes and made a part thereof.
- 3. Sue Kaslow was nominated for Chairman and elected as Chairman.
- 4. Dorie Barnes was nominated for Vice Chairman and elected as Vice-Chairman.
- 5. Approved the annual salary for the Chairman to be \$450.00 per year.
- 6. Joell Miranda was nominated for Clerk and was elected as Clerk with an annual salary of \$450.00 per year.

### City of Hill City Council Meeting February 12, 2019

- 1. Call to Order/Pledge of Allegiance
- A. Mayor Dan Kingsley presided over the meeting and called the meeting to order at 6:00 p.m.
- B. Everyone joined in the Pledge of Allegiance.
- C. Council present: Mayor Dan Kingsley, Council members Terry Christensen, Nate Rollins and Wayne Lindquist. Neal Roettger was absent.
- 2. Addition or Corrections to the Agenda There were no additions or corrections to the agenda.
- 3. Public Forum

There was no one for the Public Forum

Consent Agenda

Motion made by Christensen to approve the Consent Agenda as presented, second by Rollins. MPU

5. Reports

Maintenance/Water/Sewer/Parks/Airport/Streets

- George Casper reported that he had got new cutting edges for the plows and grader.
- · The John Deere tractor needs a new battery, alternator and voltage regulator.
- · Zack Thein was present from Thein Wells and went through a proposal for the rehab of Well 2. Motion made by Rollins to accept the estimate from Thein Wells of \$16,990.00 to rehab Well 2,

second by Christensen. MPU

- · A sewer pump needs to be pulled and unplugged.
- The cylinder on the sewer lift crane needs to be replaced. The cylinder will cost \$1,100.00 and can be taken out of the sewer improvement fund.
- There is a problem with the sewer line on Summit Ave. that is starting to freeze up. This was flushed and will continue to be flushed on Mondays to prevent it from freezing up.
- The Hill Lake Park road was plowed out for the Lion's Club Fishing contest on February 9, 2019.
- The airport was plowed February 12. 2019.
- People need to be careful when driving in town because of the high snow banks. The banks have been plowed back as far as they can be but are still difficult to see around.

Fire Dept.

- Fire Chief Jeremy Nelson gave the January Fire Dept. and 1st Responders report and stated that the month of February has started out with multiple 1st Responder calls.
- The Fire Relief Association has started doing Pull Tabs at Zorba's in Grand Rapids.
- March 7, 2019 at 7:00 p.m. is a meeting at is present. the Fire Hall with townships to go over Fair share Facilities/E amounts, etc.
- · Assistant Fire Chief Ron Saxton said that the Fire Relief Association will be starting Bingo at Zorba's every Thursday night from 6:30 9:00 starting March, 2019. If anyone is interested, they could use help with the Bingo on Thursday nights.
- Saxton said that Dan Kingsley has resigned from the Trustee Board for the Relief Association and now need a Council member to represent the city on the board.

Motion made by Rollins to appoint Dan Kingsley as the representative for the city on the Trustee Board for the Relief Association, second by Lindquist. Kingsley abstained from voting and all others voted yes. Motion carried.

Police Dept.

· Police Chief Josh Kimball gave the Police Dept. monthly report.

Mayor

- Mayor Kingsley reported that the city had an ordinance that does not allow for delays or waiver of payments for utilities bills.
- A DNR grant meeting was held on January 28, 2019 to discuss the possibility of applying for a grant for the Hill Lake Park. The grant deadline is March 29, 2019. It was decided to work on the grant and apply for it next year so there is more time to get everything together for the grant.
- Mayor Kingsley thanked the Council members and the department heads for their participation

in the workshop that was held on January 15, 2019. Fire Chief Jeremy Nelson let the Council know that the Fire Dept. had received 2 grants from Enbridge. One grant in the amount of \$4,000.00 and one grant in the amount of \$1,000.00, both grants were for equipment.

Clerk

- · Clerk McManigle reported that all of the year end reports were completed and that the office has been working on all of the copying of documents that the new CPA requested to start the 2018 city audit.
- · Clerk McManigle explained the report that she had provided the Council in regard to hours employees worked, PTO time taken and accrued and vacation time taken, accrued and cashed out per each pay period. Mayor Kingsley explained that this shows what the city's liability is.

Council

The Council had nothing to report.

Committees

Personnel – A Personnel Committee needs to be appointed but this was tabled until a full Council is present.

Facilities/Equipment - This committee consists of Council members Lindquist and Rollins.

Land Use - This committee consists of Council members Christensen and Roettger, but Roettger has submitted his resignation letter from the Council so another member needs to be appointed. Mayor Kingsley volunteered to be on this committee.

Motion made by Christensen to add George Casper to the Land Use Committee with Pat Jordan as an alternate, second by Lindquist. MPU

Motion made by Rollins to appoint Mayor Kingsley to fill the vacancy on the Land Use Committee, second by Christensen. Kingsley abstained from the vote, all others voted yes. Motion carried.

- Old Business
- A. Detachment from City Chris Wojciechowski & Joshua Philippi

Chris Wojciechowski and Joshua Philippi were present in regard to their request to have their property "detached" from the city limits. There was discussion on this and the Council decided to take a vote on the issue.

Motion made by Rollins to deny the request for Chris Wojciechowski and Joshua Philippi to detach their property from the city limits, second by Christensen. A roll call vote was taken and all members voted to deny the request. Motion carried to deny.

#### B. Walking Trail

George Casper said that he would have to try and get ahold of the City Engineer again as he has not got back to him.

C. Water budget – increase for water tower George Casper had got rates from surrounding communities on their water and sewer rates. Hill City's rates are basically in the middle of all the rates received.

Motion made by Rollins to hold a Public Hearing on March 12, 2019 at 5:30 p.m. at the Fire Hall to discuss the possible water rate increase to help fund the water tower rehab, second by Christensen. MPU

#### D. IBEW - J. Kimball

The city had received a letter from the Mn Bureau of Mediation Services in regard to Police Chief Josh Kimball joining the Electrical Workers Local 31 Union. The findings were that the Electrical Workers 31 is the certified exclusive representative for the employee falling within the appropriate unit. Mayor Kingsley explained that the Council needs to sit down with the IBEW and come up with an agreement. The city also needs to check with the City Attorney as Chief Kimball is currently under a contract with the city.

Approve Justin Clasen & Co., LTD (CPA) audit rate Motion made by Rollins to approve the audit rate as presented, second by Lindquist. MPU

#### 7. New Business

A. Approve Resolution #2019-05 - Accepting Resignation and Declaring a Vacancy on Council Motion made by Rollins to approve Resolution #2019-05 accepting the resignation of Neal Roettger from the Council and declare a vacancy on the Council, second by Christensen. MPU There was discussion on filling the vacancy and it was decided to advertise for the vacancy and take applications. Applications will be due by March 4, 2019 at 4:00 p.m.

Motion made by Christensen to hold a Special Meeting on March 11, 2019 at 6:00 p.m. at the Fire Hall for the interviews of the Council applicants, second by Rollins. MPU

B. Need to appoint a Park Improvement Committee

Motion made by Christensen to appoint Council member Lindquist, Mayor Kingsley, George Casper, Tami Meyer and a citizen as the Park Improvement Committee, second by Rollins. MPU

#### C. Park Attendant

It was decided that the Park Improvement Committee would be in charge of how to obtain a Park Attendant for the 2019 park season.

D. Approve Resolution #2019-06 Joint Powers Agreement with State of Minnesota

Motion made by Christensen to approve Resolution #2019-06 approving State of Minnesota Joint Powers Agreements with the City of Hill City on Behalf of its City Attorney and Police Department, second by Rollins. MPU

E. Approve 2019 Grant for Aquatic Invasive Species

Motion made by Rollins to approve the 2019 Grant application for Aquatic Invasive Species, second by Lindquist. MPU

F. Phased Retirement Option for Clerk/ Treasurer McManigle and change weekly hours for Clerk/McManigle and Deputy Clerk Meyer

Clerk/Treasurer McManigle is requesting the Council to approve her going under the PERA Phased Retirement Option. This would require her to go to 20 hours per week, the city would not need to pay into PERA for her any more. Clerk McManigle had given the Council breakdowns of currently what the total cost to the city is for her at 40 hours week and Deputy Clerk Meyer at 32 hours per week and also breakdowns of Clerk McManigle at 20 hours per week and Deputy Clerk Meyer at 40 hours per week. The total annual savings would be \$29,402.01 for the city. There was discussion on this and there would be a lot of things that would need to be checked into before this could come up for a vote. Clerk McManigle is to get ahold of the Union Rep. for Hill City to set up a meeting time to discuss issues that would need to be dealt with. Fire Chief Nelson asked the Council for approval to put Fire truck Unit 1 up for auction.

Motion made by Rollins to approve the Fire Dept. to put Unit 1 up for auction, second by Christensen. MPU

The March 12, 2019 will be at the Fire Hall immediately following the Public Hearing at 5:30 p.m. due to the fact that the Hill Lake Township will be holding elections and their annual meeting in the Community Room.

Motion made by Lindquist to move the March 12, 2019 Council meeting to the Fire Hall, second by Christensen. MPU

George Casper let the Council know that he would be gone March 2, 2019 through March 5, 2019. Motion made by Rollins to adjourn the meeting at 8:02 p.m.

s a single parent, Eileen felt strongly that her 10-year-old son, John, needed a male role model in his life. Her father and two brothers enjoyed being with her son, but all three lived out of state.

One day, Carlos, a neighbor, mentioned how much he and his wife missed being around children. Their two children had recently left for college, and Carlos was wishing he could find another child to spend some time with.

That was the beginning of an important relationship that developed between Carlos and John. The two would attend special events together or just hang out to talk. For one of John's birthdays, Carlos wrote and taped a story called John's Fictitious Adventure."

The more time they spent together, the more John's self-esteem grew," Eileen says. Grandparents, uncles, aunts, and cousins are important, but an adult who singles out a child and chooses to spend time with that child makes a unique difference."

Kids'

olds need most is positive social interaction with adults, says Dr. Peter C. Scales, a Search Institute author and researcher. These interactions expose young people to reallife heroes.



Sometimes adults can feel awkward around children and teenagers and not know what to talk about. They usually don't see themselves as 'heroes' or even 'role models.' Yet when adults take time to be themselves with young people, children and youth learn a lot. Psychologist Tore Hayden asked several hundred young people what they would like to talk about with adults:

- 1. Family matters and decisions
- 2. Controversial issues
- 3. Emotional issues
- Big questions and the "whys" of the world
- 5. The future
- Current affairs
- Personal interests
- What their parents were like at their age
