The Regular Meeting of the Board of Education of Independent School District No. 2, Hill City, Minnesota, was called to order by Chairman Sue Kaslow at 7:00 p.m. on Monday, October 22, 2018.

The Pledge of Allegiance was recited.

Roll Call showed the following members present: Sue Kaslow, Mark Meyer, Bambi Lange, Joell Miranda, and Dorie Barnes. Board Members absent: Jay Zapzalka. Also present was Superintendent/Principal Pat Rendle, Building & Grounds Director Eric Hill, Administrative Secretary/Payroll Clerk Lynn Major and other staff and visitor.

1. Approved the Agenda as presented.
2. Approved the following:
 - *Minutes of the Regular Meeting of September 24, 2018
 - *September 2018 bills presented for payment;
 - *Current bills through 10/10/2018;
 - *Investments and wire transfers
 - *Reviewed the Activity Fund Statement and Disbursements for September 2018;

3. Grounds Director Eric Hill reported on ICS construction updates..
4. There was no report from the School Attorney.
5. Transportation Report: No report.

City of Hill City Council Meeting

October 16, 2018

1.

A. Mayor Baker presided over the meeting and called the meeting to order at 6:00 p.m.

B. Everyone joined in the Pledge of Allegiance.

C. The following members were present: Mayor Larry Baker, Council Members Terry Christensen, Dave Lange and Tina Haugen. Marci Holm was absent.

2. Consent Agenda

Motion made by Christensen to approve the consent agenda as presented, second by Lange.

Motion carried with all members present voting in favor.

3. Public Forum

Dan Kingsley asked the Council to refrain from entering into the Union Contract until after the Nov. 6th elections, and until the new year so that the newly elected will have say in the Union Contracts. Council member Christensen felt that the current Council would be remiss in doing their jobs if they extend the Union Contract until next year. Dan Kingsley also had questions and concerns in regard to the Police Chief's contract. Kingsley feels that the Police Chief should be an "at-will" employee and not under a contract.

4. Addition or Corrections to the Agenda

There were no additions or correction to the agenda.

5. Reports

Maintenance/Water/Sewer/Parks/Airport/Streets

- George Casper reported that 2 or 3 weeks ago him and Clerk McManigle met with KLM Engineering in regard the future painting of the elevated water tower. This needs to be done within the next 2 to 3 years. KLM Engineering will be at the November Council meeting to explain everything in more detail to the Council.

- Casper said that with the heavy rain on September 15th that the city experienced a power outage that resulted in him having to use the generator to pump the main lift station since Quadna did not have a power outage and were pumping their sewer into town. MPCA also had to be called.

- The Hill Lake Park bathhouse is closed for the season- Casper and Pat Jordan having been repainting the shower walls and are in the process of redoing the floors.

- Casper thanked Park Attendant Tina Haugen, Deputy Clerk Meyer and Clerk/Treasurer

McManigle for the good season at the Hill Lake Park with the up keep and reservations.

- Casper said that he had finally gotten the streets all graded.

- On October 24th Casper and Clerk/Treasurer McManigle have a meeting with FEMA in regard to the washed-out streets and flooded Hill Lake Park.

- Casper reported that the grader needed new tires. The

current tires were put on in 2001. Casper had gotten quotes from Acheson Tire and Mesabi tire and the tires were around \$1,800.00 per tire. Casper had also gotten a quote from Pomp's Tire and their tires were \$1,263.60 for new or \$893.75 for recapped tires. Casper said that other places have been using the recapped tires and there have been no issues with them.

Motion made by Baker to purchase 6 recapped grader tires, O-rings, valves and installation, second by Christensen. Motion carried with all members present voting in favor.

Fire Dept.

- Fire Chief Jeremy Nelson said he had nothing to report, Police Dept.

- Police Chief Josh Kimball gave the monthly Police Dept. report.

- Chief Kimball said he had been checking into Solicitor permits for vendors going door to door as our Ordinance states that the City has them. An application will be needed as well as a fee for the permit. Kimball will bring these to the next meeting.

Mayor

Mayor Baker stated that a Council member had given the proposed Union Contract and the proposed Chief of Police Contract to a citizen prior to any negotiations and that the City Attorney wanted the Mayor to address this. Mayor Baker stated to let the minutes reflect that this was not done with the Mayor or the full Councils approval. This has exposed the City to possible legal ramifications. There are proper channels to be followed for data requests due to the fact that some data is private and some is public. No individual Council member has any authority to act in any way individually. Mayor Baker said that the Council (and Mayor) need to be careful of what they do and what they say. The Council needs to work together as a whole without any finger pointing or name calling.

- There will be a Budget meeting November 1, 2018 at 6:00 p.m.

Clerk

- Clerk McManigle said that there will need to be a Public Hearing to update the fee Ordinance as there are some fees that need to be addressed. i.e. Trails Inn (Quadna) motel and campground sewer charges, seasonal camping rates and anything else the Council feels needs to be changed. Clerk McManigle will get the current fee Ordinance to the Council so that they can review it for changes. The Public Hearing date will be set at the November Council meeting.

Council

- A closed Strategy Negotiations meeting was set for November 7, 2018 at 6:00 p.m.

- Council member Haugen asked if there a permit had been issued for a fence that was put up over the weekend on Gill Street. There was not a permit issued and George Casper was going to speak to the owner.

1st Responders

There was no report.

Committees: Personnel, Facilities/Equipment and Land Use

- George Casper had found a 2002 Ford F-350 4WD Boom Crane truck with 82,000 miles on it on Craig's list for \$11,000.00. Casper explained that this truck had a plow

mount on it for a Boss plow (which the city has) and could be used to plow the walking trail since it will be lighter due to it not having sand in the box. The boom crane is hydraulic and will be used to pull sewer pumps. Casper said that the sewer improvement fund could pay for ½ of this vehicle and that he has the money in the Maintenance Equipment fund to pay the other ½.

Motion made by Haugen to approve purchasing this vehicle if it meets with Casper's approval after seeing it and that the money will come out of the Sewer Improvement fund and the Maintenance Equipment fund, second by Christensen. Motion carried with all members present voting in favor.

6. Old Business

A. Quadna Motel/Campground (Trails Inn at Quadna) Sewer Billing

Casper had met with Ranae Rassmussen from Trails Inn at Quadna and explained that as soon as they put the meter into the motel the Bat sewer rate of \$765.00 per month for (20 motel rooms and 31 campground sites) will be reduced to \$465.00 for 31 campground sites and then the actual usage for the motel. Ranae Rassmussen had agreed to this. Clerk McManigle reminded the Council that they needed to make a motion on this change.

Motion made by Lange to approve the sewer rate change for the Trails Inn Motel as soon as they get the meter installed, second by Baker. Motion carried with all members present voting in favor.

B. Class 5

Casper said that he never received another bid for the Class 5. Next spring when he puts out for bids he will putting out for both Class 5 and for the hauling of the Class 5. Casper asked the Council who they wanted him to buy Class 5 from in case he needed some yet this year. Mayor Baker said to buy it from the lowest bidder. Casper also let the Council know that Class 5 was going to cost more next year.

7. New Business

A. Set Truth-in-Taxation meeting

The Truth-in-Taxation meeting was set for 5:30 p.m. on December 11, 2018 before the Regular Council meeting. Canvassing of the votes from election will take place at the Regular Council meeting November 13, 2018.

B. Electric meters – RV sites

Casper had obtained a quote from Benham Electric to install electric meters on each of the 5 newer RV sites next spring at a cost of \$2,470.00.

Motion made by Baker to have the electric meters installed, second by Christensen. Motion carried with all members present voting in favor.

C. Sell Chairs

Clerk McManigle asked if the Council was interested in selling some of the 70 chairs that were purchased last year. It was decided to wait until the Booring is completed and to see if the City gets new tables to decide how many chairs are needed.

D. Police Chief and Union Contracts

These will be going to the closed Strategy Negotiations meeting November 7, 2018 at 6:00 p.m.

E. Trunk or Treat – Dave Lange

Council member Lange said he was asked if the City Hall/Community Room bathrooms can be open for Truck or Treat on Lake Ave. on October 31, 2018. Council member Haugen said that she could also be here to monitor the restrooms.

Motion made by Baker to have the bathrooms open for Trunk or Treat, second by Haugen. Motion carried with all members present voting in favor.

F. Approve Resolution #2018-15, Accepting Resignation of Council Member Holm and Declaring a Vacancy

Motion made by Haugen to accept the resignation of Marci Holm from the Council and to declare a vacancy, second by Christensen. Motion carried with all members present voting in favor.

G. Approve Resolution #2018-16, Appointing Person to Fill a Vacancy

There was quite a bit of discussion on this with citizen Dan Kingsley and Council member Haugen wanting the appointment to wait until after the elections. There also were a couple of names discussed as possible appointments.

Motion made by Christensen to appoint Neal Roettger to fill the Council vacancy, second by Baker. Christensen voted yes, Baker voted yes, Haugen abstained and Lange abstained.

Clerk/Treasurer McManigle explained that in case of a tie on the voting for a vacancy appointment was the only time that the Mayor had more power and could break the tie and appoint anyone to the vacant Council seat. Citizen Dan Kingsley said that this was incorrect and because the Mayor was part of the original motion he could not break the tie.

Mayor Baker appointed Neal Roettger to the vacant Council seat through 2020.

Citizen Dan Kingsley said that this was incorrect because the Mayor was the second on the motion that he could not break the tie. (Clerk McManigle checked with the City Attorney the morning of October 17, 2018 and she was correct, because there was a quorum present and the vote was 2-0 the Mayor could appoint whomever he wanted). Neal Roettger was appointed.

Motion made by Christensen to adjourn the meeting at 7:38 p.m., second by Baker.

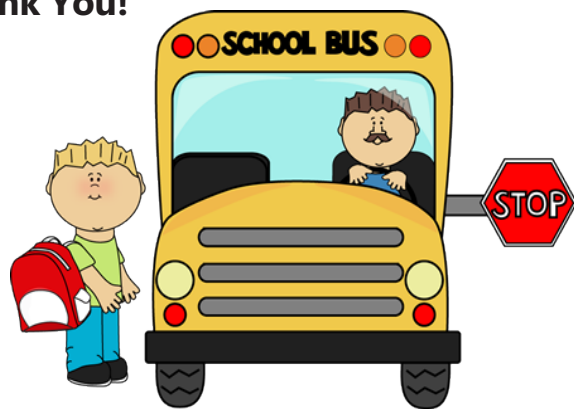

What Are Assets?

Assets are 40 key building blocks to help kids succeed. "School boundaries" is one of six boundaries and expectations assets.

* Based on Search Institute surveys of almost 100,000 6th- to 12th-grade youth throughout the United States.

Working Together to Form Boundaries

An assistant principal of a middle school in Colorado was fed up with discipline problems. So many students were behaving badly that he expelled 97 of them.

Then the assistant principal was suspended. Why?

Because while some parents and teachers supported his action, many thought the expulsions were too extreme and poorly handled. They demanded his suspension because they felt he was using unusually harsh punishment to enforce school boundaries.

All schools need boundaries. They need to set clear standards and expectations for how students should act and learn. Yet setting these standards isn't easy—and neither is enforcing them. Many schools grapple with how to discipline students in appropriate and effective ways.

As a parent you can help the process by working with your child's school. Encourage your school to create a conduct code at the beginning of the year, review the code with the students, and send a copy of it home to inform parents. Suggest that students help in



creating the code. For example, Streetwater High in National City, California, created "The Link Crew"—twelfth graders who explained the dos and don'ts of behavior to new students and talked with students with whom teachers were struggling. Grades and attendance improved, and fewer new students spent time in the principal's office.

When parents and educators work together, they can create a supportive environment for establishing and enforcing school boundaries. And the more families, schools, and communities work together to establish consistent boundaries, the better off our children will be because they will know what to expect.

Helpful Hints

Tips that make creating clear school boundaries easier:

- **Get involved in a parent-teacher policy organization.**
- **Focus on the positive and build on what's working.**
- **When conflicts occur, don't be pushy. Calmly state your concern and suggest solutions.**

Evaluate Your Child's School

Inform yourself about school boundaries by visiting your child's school and asking yourself these questions:

- Overall, how are students behaving?
- How do adults and students interact with each other?
- When conflicts occur, how are they resolved?
- How do the school boundaries you observe match the boundaries you have at home?

What's Your View?

Public Agenda interviewed more than 1,100 Americans about education reform. They found that:

- 54% say teachers are doing either a "fair" or "poor" job dealing with discipline.
- 52% say it is a serious problem that local public schools aren't teaching good work habits, such as being on time and doing homework.
- 49% say the worst-behaved students are getting most of the attention.

Do you agree with these statements when you think about the education your child is getting? Why or why not? Contact the president of your school-parent group (such as a PTA or PTO) and raise these issues. Or talk to the principal or a teacher. Discuss how parents and educators can work together and make school boundaries an issue people feel good about.

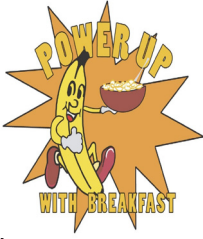
