The Regular Meeting of the Board of Education of Independent School District No. 2, Hill City, Minnesota, was called to order by Chairman Tom Fasteland at 7:00 p.m. on Monday, October 27, 2014.

Roll Call showed the following members present: Tom Fasteland, Sue Kaslow, Martha Lentz, and Brent Welk. Board Members absent: Mark Meyer. Also present was Superintendent/Principal Dean Yocum, Business Manager Ellie Hill, Maintenance Supervisor Eric Hill, and a few visitors.

Official Oath of Office was administered to Jay Zapzalka by Chairman Tom Fasteland.

- 1. Approved the Agenda as presented.
- 2. Approved the following:
 - *Minutes of the Regular Meeting of September 29, 2014;
 - *September 2014 bills presented for payment;
 - *Current bills through 10/08/14;

- 3. No comments or requests from visitors.
- 4. There was no report from the School Attorney.
- 5. Transportation Report: No report.
- 6. Student Council: No report.
- 7. System Accountability Committee: They met on October 21, 2014. Martha Lentz reported that the survey is ready on Parent Portal and a paper copy is available in the district office. Also discussed was the World's Best Work Force and setting district goals. There has been some weaknesses identified in the math curriculum and they are working to correct these.
- 8. School and Community Health Committee: They will meet on October 31, 2014.
- Safety/Transportation Committee: Tom Fasteland reported on the Safety/Transportation meeting. They discussed upgrading the security system; SDS sheets must be all new by January 2015; and AED training for staff. There will be new signs ordered for the fire lane in the drive through.
- 10. Negotiation Committee: None to report.

- 12. Maintenance Supervisor report: Maintenance Supervisor Eric Hill reported that our insurance company recommends a bonded, insured contractor to remove fallen trees from the school forest. Approved to advertise for contractors to remove trees from the school forest.
- 13. Superintendent/Principal Yocum reported that IASC is working on strategic planning for technology. Also the principal's meeting once a month is now a Professional Learning Community.
- 14. Superintendent/Principal Yocum handed out information from MSHSL on cooperative sponsorship of activities. There was very good discussion on the process of

- cooperating with Northland Community Schools for football.
- 15. Information was handed out on Professional Learning Communities which will start on November 5, 2014.
- 16. Approved hiring Brian Burman as Assistant Boys' Basketball Coach for the 2014-2015 school year with a salary to be set according to the current HCUE Master Agreement.
- 17. Approved hiring Chad Lathrop as Assistant Girls' Basketball Coach for the 2014-2015 school year with a salary to be set according to the current HCUE Master Agreement.
- 18. The remainder of the activity/coaching positions for 2014-2015 were tabled.

Parents' Corner

PLC's- On Wednesday afternoons, starting at 2:34, the teaching staff is participating in Professional Learning Communities. During this time, teachers are working on technology, teacher growth and other important staff development. Our goal is, of course, increased student achievement and we are working on collaborating with each other in meaningful ways to make this happen. What happens with your student during this time? Well, actually a variety of interesting things are going on. Kay Koerber and Laurie Holm have been coordinating group of 9-12 grade students in a Peer Leadership program. Working in teams of three, these students are partnered with an elementary classroom and a paraprofessional to teach the students Second Step lessons. The Second Steps curriculum is a bullying prevention program that focuses on teaching respectful behavior, empathy, appropriate social skills, etc. So far, we have had great reports. The elementary students really enjoy having the high school students in their class and interacting with them. And those important messages about treating everyone with kindness and respect seem to be even more meaningful when coming from older students.

Students in grades 6-8 are divided up into two groups for the 30 minutes or so they are here. In those groups they have two options, they can work on homework or they can do Silent Sustained Reading. We have some peer leaders who are not assigned to elementary classes that we would like to tutor the middle school students during PLC time, and we are working on implementing that as well. The 9-12 grade students who are not in the Peer Leadership program are also divided into two groups, and they can work on homework or have Silent, Sustained Reading time as well. If you have any ideas or an interest in offering some enrichment activities or topics for the middle or high school students, we'd love to hear from you! This program is something we've never tried before, so we are continuously evaluating and revising what we are doing.



Working Together to Form Boundaries

n assistant principal of a middle school in Colorado was fed up with discipline problems. So many students were behaving badly that he expelled 97 of them.

Then the assistant principal was suspended.

Because while some parents and teachers supported his action, many thought the expulsions were too extreme and poorly handled. They demanded his suspension because they felt he was using unusually harsh punishment to enforce school boundaries.

All schools need boundaries. They need to set clear standards and expectations for how students should act and learn. Yet setting these standards isn't easy—and neither is enforcing them. Many schools grapple with how to discipline students in appropriate and effective ways.

As a parent you can help the process by working with your child's school. Encourage your school to create a conduct code at the beginning of the year, review the code with the students, and send a copy of it home to inform parents. Suggest that students help in

- · When conflicts occur, don't be pushy. Calmly state your concern and suggest solutions.



creating the code. For example, Streetwater High in National City, California, created "The Link Crew'-twelfth graders who explained the dos and don'ts of behavior to new students and talked with students with whom teachers were struggling. Crades and attendance improved, and fewer new students spent time in the principals office.

When parents and educators work together, they can create a supportive environment for establishing and enforcing school boundaries. And the more families. schools, and communities work together to establish consistent boundaries, the better off our children will be because they will know what to expect.

Evaluate Your Child's School

Inform yourself about exhool boundaries by visiting your child's echool and asking yourself these questions:

- · Overall, how are students behaving?
- How do adults and students interact with each other?
- When conflicts occur, how are they resolved?
- How do the achool boundaries you observe match the boundaries you have at home?

1. Call to Order/Pledge of Allegiance/Roll Call

5. Reports

Maintenance/Water/Sewer/Parks/Airport/Street

- George Casper reported that the 1 ton was fixed.
- Casper reported that they are currently discharging the sewer ponds.
- Casper wanted to know if it was okay to close the Park Rd. as kids have begun sliding with the new snow. It was decided that Casper would notify the people living on Park Ave. of the

closure and close the Park Rd. on Friday, Nov. 14th.

- There was nothing to report with the airport.
- Casper reported that there is shortage of salt this year. Casper got some premixed salt and sand and was going to also get 2 pallets of salt.
- Casper reported that the backup camera on the 1 ton broke last year and would like to replace it at a cost of \$250.00 to \$300.00. The Council said this was within Casper's spending limit and to go ahead and replace it.
- Casper said that the tool box at the shop was in need of being updated and he would spend under \$500.00 to purchase a new tool box. The Council approved this as this also was under Casper's spending limit.

Fire Department

Asst. Fire Chief Boleman stated that the fire department had one call last month. Also the Fire Department had approved Kayla Perkins and Chaneal Harrison to be placed on the department.

• Clerk McManigle reported that there had been so many law changes that the city had received a complete new Minnesota Basic Code of Ordinances versus just various individual pages to replace. Clerk McManigle said that the Council and staff needed to go through the entire MBC before adopting it and asked if the Council wanted paper copies or just computer discs. The Council stated that they would all just like a copy of the disc.

Council member Baratto stated that Deputy Clerk Meyer had gotten ahold of Leah Heggerston in regard to doing a Feasibility Study on the Shorewood Campground. Leah had given Meyer names of people that did Financial and Marketing Feasibility Studies, some possibly at no charge. The Council said to go ahead and have the studies done only if there was no charge to have them done.

1st Responders

Mike Bolemen reported that the 1st Responders need more members.

Council member Rollins said that he had not seen the Council meeting minutes in the school newsletter in a couple of months and that they are also not on the city website.

Clerk McManigle explained that the minutes cannot go in the first newsletter of the school year as the school has so much information they put into the newsletter. October's minutes were not in the newsletter as the Council meeting was so late in the month the cutoff time could not be met. The Council meeting minutes had been on the city website but somehow they "disappeared" and Deputy Clerk Meyer was trying to locate them. Council member Rollins wanted them located and put back on the site.

Motion made by Roettger that for any large city project, all requests for staff time, etc. goes through the Mayor to help avoid miscommunications, and individual Council members directing the staff, second by Baratto. Motion carried with all members present voting in favor.

Committee Reports

Personnel – There was nothing to report Facilities/Equipment – There was nothing to report Land Use – There was nothing to report.

6. **Old Business**

A. Quadna – disconnect from city sewer

The city received a letter from Ryan & Brucker, LTD representing Quadna asking that the city approve the Quadna Lodge to insert inflatable plugs in the sewer line versus completely disconnecting from the city sewer in order to stop assessing sewer charges. This letter was forwarded on to Hill City's attorney, Brad Person, who has been in contact with Quadna's attorney in regard to the disconnection and the past due billings totaling \$22,866.00 which is going to be assessed to Quadna's property taxes.

Motion made by Rollins to have the City Attorney, Brad Person, talk to the City Engineer, Bob Beaver, to help draft a letter to Quadna's attorney of why the city wants the sewer line completely disconnected from the city's sewer versus installing an inflatable plug. Sewer charges will continue to be applied to Quadna until the actual disconnection takes place. Second by Roettger. Motion carried with all members present voting in favor.

B. Water Treatment Recommendation

The iron level in one of the city's wells is very high and untreatable. After multiple testings it was discovered that there is iron bacteria on the well casing and that the well will need to be rehabilitated. George Casper received two quotes for this, one from Traut Wells in the amount of \$10,092.50 and a quote from Thein Well in the amount of \$15,375.00 plus televising and replacement materials. After going over the two quotes, the Council came to the conclusion that the quotes are not "apples to apples" and that Thein Well has a lot more to offer.

Motion made by Rollins to accept the quote from Thein Well plus the televising, second by Roettger. Motion carried with all members present voting in favor.

Clerk McManigle was instructed to send Michelle Raskin a letter inviting her to the next Council meeting as the running of her water will be discussed.

7. New Business

A. Approve Assessments

Motion made by Baker to approve the delinquent water/sewer and garbage billings to be assessed against the property taxes except for the ones that pay the delinquencies before the list is sent to the County Auditor, second by Roettger. Motion carried with all members present voting in favor.

B. Approve Liquor Licenses

Motion made by Baker to approve the Liquor License Renewals as long as all businesses are in compliance with all of the necessary documents, second by Rollins. Motion carried with all members present voting in favor.

C. Canvass Election Results


