BE IT RESOLVED by the School Board of Independent School District No. 2310,
State of Minnesota, as follows:

1. It is hereby found, determined and declared that the general election of the voters
of this school district held on November 8, 2022, in conjunction with the state
general election, was in all respects duly and legally called and held.
2. As specified in the attached Abstract and Return of Votes Cast, a total of 4553
voters of the district voted at said general election on the election of three (3)
school board members for four (4) year term vacancies on the board caused by
expiration of term on the first Monday in January next following the general
election as follows:

3. Sarah Zeigler, Laura Reid, and Ashley Latzke having received the highest number of votes, are elected to four (4) year terms beginning on the first Monday in January, 2023.
4. The clerk is hereby directed to certify the results of the election to the county auditor of each county in which the school district is located in whole or in part.

F. RESOLUTION AUTHORIZING ISSUANCE OF CERTIFICATE OF ELECTION AND DIRECTING THE SCHOOL DISTRICT CLERK TO PERFORM OTHER ELECTION RELATED DUTIES

WHEREAS, the board has canvassed the general election for school board members held in conjunction with the state general election on November 8, 2022.

NOW THEREFORE, BE IT RESOLVED by the School Board of Independent School District No. 2310 (Sibley East Public Schools), State of Minnesota, as follows:

1. The chair and clerk are hereby authorized to execute certificates of election on behalf of the school board of Independent School District No. 2310 to the following candidates:
 - a. Sarah Zeigler
 - b. Laura Reid
 - c. Ashley Latzkewho have received a sufficiently large number of votes to be elected to fill vacancies on the board caused by expiration of term on the first Monday in January next following the election, based on the results of the canvass.
2. The certificate of election shall be in substantially the form attached hereto.
3. After the time for contesting the election has passed and the candidate has filed all campaign financial reports required by Minnesota Statutes, Chapter 211A, the clerk of the school board is hereby directed to deliver a certificate to each person entitled thereto personally or by certified mail.

4. The clerk is hereby directed to enclose with the certificate a form of acceptance of office and oath of office in substantially the form attached hereto.


The motion for the adoption of the foregoing resolution was made by member Grochow and duly seconded by Lueth and upon vote being taken thereon the following voted in favor thereof:


whereupon said resolution was declared duly passed and adopted.
