The meeting was called to order at 6:32 p.m with the salute to the flag, all members were present. Member_Grochow moved, second by member Lueth, to approve the agenda with revisions. The motion was approved.

Recall / Resignation Protocols - (No Action Needed) After consultation with SEIU Local 284 and district legal counsel, it has been determined that; based on new contract language and the rights of each union member, the actions of the school district in offering an open position to the most senior person on the recall list was appropriate. When the position was not accepted, asking for and receiving a letter of resignation over a termination of employment was also seen as the most appropriate action to take by the district.

A motion by Member Reid, second by Member Lueth to consider approval for the Sibley East Alumni Association to pursue a site survey and private funding for a potential fieldhouse on school property, located at the football, tennis courts, baseball field location. Motion was approved with a 5-0 approval. Member Grochow abstained from the vote.
