A motion by member Reid and seconded by member Ziegler, to approve the agenda with revisions. The motion was approved.

Member Reid moved, second by member Lueth, to approve the proposed FY2025 General, Food Service and Community Service District Budgets. The motion was approved.

Member Ziegler moved, second by member Latzke, to approve the Long Term Facilities Maintenance (LTFM) Ten-Year Revenue Projection FY25-FY34. The motion was approved.

Member Reid moved, second by Member Latzke, to approve the Long Term Facilities Maintenance (LTFM) Ten-Year Expenditure Plan for FY25-FY34 as presented. The motion was approved.

Member Grochow moved, second by member Ziegler, to approve the submitted plan as written for inactive student accounts. The motion was approved.
