k. Authorize the publication of salaries.

l. Set admission charge for the 2021-2022 school year as \$5.00 for adults, \$3.00 for students or \$1.00 for advanced student activity tickets for regular season events and \$60.00 for adult season passes. Playoff event admission prices are according to State guidelines.
