- 13. Motion made by Risseeuw, seconded by Storms and carried to approve designating local depositories of the school district as Bank West, First Fidelity Bank, Wells Fargo, and Sentinel Federal Credit Union. Long abstained.
- 14. Motion made by Storms, seconded by Kubik and carried to approve the annual School Bus Mutual Assistance Pact with surrounding school systems.
- 15. Hold 09-10 Budget Hearing. Business Manager Root said budget had been cut by 21% from the 08/09 budget. They will adopt the budget in September after the new board members have a chance to look at it and more is finalized on the stimulus funding.
- 16. Motion made by Covey, seconded by Risseeuw and carried to table designating Jensen and Massa as official school district attorney at an hourly rate of \$140.00 for the 2009/2010 school term. Brenda Jorgensen spoke on the issues she has with Jensen not voting on our recent opt outs and not sending his children to the WSD. Covey stated that he has a problem with increased rates during the schools financial problems. Risseeuw stated that she has a problem with him not participating in our school happening. Kubik said that he spoke to other school board members in other districts and he is highly recommended and also individuals at the state level. Hanson spoke about Jensen's high qualifications with school law and that Jensen is highly regarded as a school attorney.
- 17. Motion made by Long, seconded by Covey to approve contracted services for 2009/2010 school year as follows:
 - Winner Physical Therapy at \$44.46 per half hour for direct services and \$21.66 per half hour for indirect services. 3% increase
 - Occupational Therapy Sarah Wold Hanson for \$1750.00 per month for direct and indirect services. No increase
 - Psychological and Educational Evaluation Diane Mueller, School Psychologist at \$25.00 per fifteen minute unit and state rate per mile for transportation. No increase
 - Pre-school Special Education Services, Toni Donavan \$25.73 per hour. No increase
 - Southern Plains Behavioral Center at \$21.00 per 15 minute unit. \$15.00 per hour for attendance at IEP/Behavioral meetings. No increase
 - Lenna Thieman, The Right Path Counseling Services, for some contracted counseling services at \$20.00 per 15 minute units as needed. No increase
 - Winner Regional Health Care Center Preventive Care for Children/Student Education/Employee Preventive Care/Employee Education at \$31.20/hour for 195 contract hours. Total dollar amount \$6,084.00. 4% increase

- Winner Community Playhouse for school district use. \$5300.00. Reduction of \$400.00
- APEX Technology Solutions, \$2,562.00 per month (9 months) and \$450.00 per day for summer work. 6% increase

- 20. Motion made by Long, seconded by Risseeuw and carried to approve Pat Rehak as elementary school special education aide at a salary of \$8.76 hour plus benefits.
- 21. Motion made by Risseeuw, seconded by Long and carried to approve Audrey Keierleber as high school special education aide at a salary of \$7.25 hour plus benefits.

- 30. Approve School Board Policy 8.08 Winner School District Parent Involvement:
- Title I. This policy was amended in the 08-09 academic year but must be approved each academic year.
- 31. Approve amended School Board Policy 8.19 Complaint Policy for Federal Programs. This policy must be approved each academic year.
- 32. Motion made by Long, seconded by Kubik and carried to approve School Board Policy 8.20 Winner School District Homelessness Policy. This policy must be approved each academic year. No changes at this time.
- 33. Motion made by Meyer, seconded by Covey and carried to disapprove authorizing administration to advertise for bids for highway fuel and propane.
- 34. Motion made by Long, seconded by Kubik and carried to approved bids for (one) 1000 gallon propane tank for \$501.00 and (one) 1000 gallon diesel fuel tank for \$401.00.

DISCUSSION ITEMS:

- a. School Finance and Opt Out Resolution: Discussion was held on the opt out. Mike Calhoon stated that he wanted to take a six month break and talk again in January. The K.I.D.S group pledged \$100,000 and they will be looking at several options through committees. Doug Long felt that we should also take a break. Marsha Risseeuw stated that she does not want the financial issue to go to the back burner. She stated that we can't go on without giving raises in our district. Calhoon agreed. Dawn Covey spoke that our community is pulling together and commented on the KELOLAND interview by Doug Long. The interview made it sound like Doug Long said that area ranchers voted the opt out down. Doug said he was misquoted and that he was talking about how the opt out affects everyone. That area farmers/ranchers do see a large increase in their taxes and that people working in town are watching their 401K's split in half. Doug Wiken asked about a 4 day school week.
- b. WSD Athletic Events Adult Sports Pass for 09-10 school year.

- 35. Motion made by Long, seconded by Kubik and carried to approve WSD Athletic Events Adult Sports Pass for the 09-10 home athletic events. This pass would include home events, but excludes the Snowball Classic, Winner Wrestling Tourney, regional and state events and all plays. This pass will be \$45.00.
 - c. Football Field Parking: Sale/Auctioning parking spots for 09-10 home football games. There was discussion on a potential lottery system that people who buy chances to park on the hill. Much discussion was held and no action taken.
 - d. The ASBSD Conference is in Sioux Falls, August 6th and 7th. They discussed and appointed Mike Calhoon as a delegate and Dr. Tom Covey as the alternate delegate. These two board members said that they would get back to Mike. Marsha Risseeuw is also attending.
