# Treasurer's Report:

- Balance of \$9767.30
- Still getting squared away with the transition from Dan Tripp
- Should have the account open ASAP
- The due date for dues has been extended to October to facilitate the transition.
- There was a question regarding a co-op dues and whether both schools would be required to pay the dues.
  - The answer was that if both schools are vocational schools they are required to pay.

- There was discussion about spring sports tournaments and going to just a final game or remaining with the current system of semifinals and finals

- The discussion involved athletic directors and the consensus was to continue with the current format
- The by-laws were discussed regarding opting out of the tournament and the timeline to do so.
  - Terry stated that the by-laws state that the cutoff date is a commitment date.
    - Notification of opting out should be 1 week before the said cutoff date
    - Refusing to participate after will result in sanctions
- Football alignment
  - Lynn Tech stated their case of middle schoolers not being part of their program.
    They are in Division 8 in football and would like to move to our Small school division in football.
    - Adolph Graciale presented the case for Lynn Tech
    - Don Heres spokane on behalf of Lynn Tech
    - Al Costabile spoke on behalf of Lynn Tech
    - The vote was unanimous for Lynn Tech to move to the small school division and Essex Tech to move to the Large school division
- Dated of the MVADA calendar were presented, discussed, and approved
  - Discussion of our MVADA Cross Country Championships was discussed
    - Don Heres will talk to the CAC at their league meeting and will contact the board regarding their League Meet
- Fall tournament and cutoff dates were presented
  - Terry will send reminders
