The OCIAA Athletic Directors Workshop was called to order at 9:31 am via Zoom.

- 1. Approval of Minutes of Last Meeting (August 24, 2021)

  Motion to approve minutes made by Ms. Debbi Crowe (Highland Falls/O'Neill) and seconded by Mr. Lou Cioffi (Goshen). All in favor. Motion carried.
- 2. Wrestling Proposals Mr. Jeff Cuilty
  Mr. Cuilty presented two proposals to add to the Handbook:
  - a. Selecting a true second place in Division I Wrestling
  - b. Supplementing the expenses for two (2) athletic trainers to attend the State Wrestling Tournament

Motion to approve both proposals made by Mr. John Landro (Tuxedo) and seconded by Ms. Sue Lendzian (Fallsburg). All in favor. Motion carried.

- 3. NYSPHSAA Update Mr. Greg Ransom Mr. Ransom reviewed discussion items in your materials. State Championships are still on and NYSPHSAA will continue to abide by the COVID guidelines throughout the season.

# **NYSPHSAA Voting Items**

## **Criteria for 6th Classification:**

**Motion:** – Approval of establishing criteria for the creation of a 6<sup>th</sup> classification for sports with 501 or more teams competing in the NYSPHSAA State Championships.

Rationale: Provides more equity for teams

## **Classification cut off format:**

**Motion:** Approval to establish a timeline, process and criteria for the classification cutoff numbers for non-variation five, four, three classification sports and two division sports pending approval of the Championship Advisory Committee proposal.

Rationale: To revise the current non-variation classification process for greater accuracy, consistency, and equity.

## These two proposals will be voted on at the next Athletic Directors' meeting in October 2021.

## ❖ 1. Approve New Regional Assignments for Girls Volleyball for 2022-2025

<u>Motion:</u> Approval of new four year regional assignments from 2022-2025 for NYSPHSAA Girls Volleyball **Rationale:** Current rotation expiring after 2021 and it is necessary to make some adjustments due to imbalance in numbers.

### 2. Boys and Girls Swimming: Allow Schools to enter relay teams without individual athlete names.

**Motion:** NYSPHSAA Boys and Girls Swimming Diving Committee seeking approval to allow schools to enter relay teams without individual athlete names.

Rationale: Will allow coaches flexibility in managing their relay events.

## ❖ 3. Tennis: Mandate all players to "Claim" profiles on UTR and Require schools to submit season results.

**Motion:** Mandate all players to "Claim" profiles on UTR prior to the season and Require schools to submit season results in a timely fashion. Athletes with unclaimed profiles or incomplete match results will be ineligible for postseason competition.

**Rationale:** Will allow NYSPHSAA and Tennis committees to utilize a complete database at the end of the season to properly seed the state tournament.

## **❖** 4. Girls and Boys Tennis: Regional Rotations – 6 year cycle.

Motion: Adopt 6 year regional rotation for the tennis team Championships.

Rationale: Allows sections to take turns hosting.

## **❖** 5. Competitive Cheerleading – Increase Minimum number of contests to qualify for states.

**Motion:** Increase Minimum number of contests to qualify for states from 2 to 3.

Rationale: Encourages schools to participate on a more regular basis.

#### **❖** 6. NYSPHSAA Amateur Rule Revision

Motion: Revise the language in the Amateur rule to reflect the current climate

Rationale: Basically - Times change and we need to change with them. See Packet for actual language.

Motion to approve proposals 1-6 above made by Mr. Landro (Tuxedo) and seconded by Ms. Crowe (Highland Falls/O'Neill). All in favor. Motion carried.

- Wrestling would like to send 1 or 2 Athletic Trainers from Section IX to the NYSPHSAA Tournament.
  - Friends of Section IX would pay for the Hotel Room.
  - Section IX is requested to pay for their meals, mileage and any difference in the pay rate from NYSPHSAA.

Motion to approve made by Mr. Landro (Tuxedo) and seconded by Mr. Cioffi (Goshen). All in favor. Motion carried.
