The OCIAA Athletic Directors Workshop was called to order at 9:31 am via Zoom.

- 1. Approval of Minutes of Last Meeting (November 23, 2021) Motion to approve minutes made by Ms. Debbie Crowe (Highland Falls/O'Neill) and seconded by Mr. Tim Bult (Minisink). All in favor. Motion carried.
- 2. Section IX Update Greg Ransom / Jim Osborne
 - a. Mr. Ransom forwarded memo from Dr. Robert Zayas to Athletic Directors reminding all of the current mask mandate.
 - b. Governor is planning to provide schools with two million rapid tests after the new year with the intentions to keep students in school.
 - c. Cheerleading Championship location requires vaccinations photo ID and vaccination card will be required by each individual.
 - d. State Championships Mr. Mayo requested Mr. Ransom to inquire with NYSPHSAA's Dr. Zayas to ask if he could create a document comprised of all Championship locations, spectator guidelines, and vaccination policies.
 - e. State tournament teams substitute teams Discussion occurred regarding whether or not to send the runner up to Regionals/States if the winner is affected by Covid in non-vaccinations and/or quarantine. Mr. Tim Bult, Minisink, stated that Section IX should have a plan in place prior to sectional tournaments to determine what will occur if a championship team cannot continue into the State Tournaments. School districts would need to be aware of the possibility that their team, as the runner up, could potentially move on to Regionals in basketball or

States in Cheerleading in place of the Section IX Champion if that school was unable to continue due to lack of vaccinated athletes, or a quarantine situation. Mr. Ransom felt that this would be a question for the Section IX Athletic Council to weigh in on, rather than the Athletic Directors voting on this issue at this meeting. Mr. Ransom is going to contact the Superintendents on the council to gauge their feelings on this issue. Mr. David Coates, Middletown, voiced his opinion that the Section should be sending a representative to the state tournament, even if it is the runner up. Mr. Mayo agreed with that sentiment, but also asked whether or not a school, when dealing specifically with Cheerleading, should know prior to the sectional cheerleading championships whether they had the required numbers of vaccinated athletes to compete in the State Championships, since vaccinations are required in that building. Further discussion was had and Mr. Ransom said this will be discussed with the Section Athletic Council at the Tuesday, January 4th meeting.
