- 2. Section IX Report Mr. Greg Ransom / Mr. Jim Osborne
 - a. Section 2 Proposal is still in discussion status so no vote on this proposal today.
 - b. Vote for Mr. Joe DiMattina as Section IX Softball Chairperson *Motion to approve made by Mr. Tim Bult (Minisink) and seconded by Mr. Rich Silverstein (Kingston). All in favor. Motion carried.*
 - c. Cross Country bibs to be purchased by Section IX each year and billed back to schools. *Motion to approve made by Mr. Bult (Minisink) and seconded by Mr. St. Lawrence (Goshen). All in favor. Motion carried.*
 - d. Section IX Girls Lacrosse Chairperson interest from someone in Cornwall; vote will occur at next meeting.

- e. Vote for Mr. Coates to replace Mr. Jim Wolfe as Section IX Male Representative due to Mr. Wolfe's resignation. Please let Section IX know if you are interested in replacing Mr. Coates' prior position as an OCIAA League Representative.

- 3. OCIAA President's Report Mr. Michael Bellarosa A summary sheet and State Proposals have been included in meeting materials.
 - a. State Proposals Vote:
 - i. Section 2 Proposal: Change NYSPHSAA Combining of Teams Rule for K-8
 Districts want to add a #6 to the existing rules.

 This proposal is still in discussion, no vote yet.
 - ii. Sportsmanship: NYSPHSAA Sportsmanship Spectator Expectation add statement to NYSPHSAA Handbook. Motion to approve made by Mr. Coates (Middletown) and seconded by Mr. Jason Semo (Cornwall). All in favor. Motion carried.
 - iii. Sportsmanship: NYSPHSAA Spectator Sportsmanship Regulation add penalties to the Handbook. Discussion ensued regarding the challenges to enforce and follow through with it.

 - iv. Unified Sports: Waiver of the NYSPHSAA Representation Rule approve to waiving letter "e" for a one-year pilot program.

 - v. Unified Sports: Mandate the NFHS Coaching Unified Sports Course recommend taking the course within two years.

e. Girls Tennis Team Representative (Section IX Process Proposal)

The proposal is included in meeting materials. The Section IX Tennis Chairpeople were looking for both the MHAL and OCIAA Athletic Directors to approve their process for team championship representation to the Section IX Team Championship for both boys and girls tennis. The Chairpeople felt it was extremely important to have a process in writing. They will post the process on the Section IX Tennis webpage and have asked both leagues to include the Section IX process as a notation in each League's respective bylaws. Mr. Mayo informed the ADs that it cannot be included in the Girls by-laws for this Fall, due to the timeline of the implementation of change listed in the OCIAA constitution, but that it could be listed in the Boys by-laws as a notation based on the timeline for bylaw changes listed in the constitution. The addition of this process as a notation in the bylaws will be presented to the executive committee at the October meeting.

5. Discussion – Coaching Certification

A meeting took place with Ms. Nohemi Munoz, Orange Ulster BOCES Regional Certification Officer, Mr. Mayo, Mr. Coates, Mr. Semo, and Mr. Gillespie to go over this process and discuss the pitfalls and possible solutions to issues faced by both Athletic Directors and Ms. Munoz. The Athletic Directors discussed the many issues they have with State Ed's process including getting online courses verified and signed, months-long delays from State Ed's Certification center in issuing licenses, as well as problems with the Teach system = including: 4 month-long delays in getting new passwords, and the Teach System randomly closing and forcing applicants to re-start the process. New coaching application checklists are included in the meeting materials as well as a new streamlined coaching evaluation form. The meeting was very beneficial for all.
