Mr. Mayo asked if there was a way for processing renewals, rather than starting over in annual repeat requests. Mr. Bult (Minisink) shared that timeliness is the biggest challenge in this process. Discussion ensued, and it was determined that streamlining the process in allowing the Committee to approve sub-Varsity mergers without the consent of the Section IX Council would prove helpful in time-sensitive requests.

#### 5. Old Business

Mr. Dan Morse reminded everyone that Indoor Track manifests are due this week for West Point, which is scheduled for this weekend.

#### 6. New Business

- a. Mr. Ransom mentioned this is coming up the pike ... Track wants to get rid of the hand timer for qualifying. FAT (Fully Automatic Timing) would be needed in order to qualify. Discussion ensued. More information will be provided as it becomes available.
- b. Mr. Greg Sirico (Warwick) announced the need for a County Track Meet location on Friday, May 19, because the Warwick Track is currently under construction. Since it does have an early start, he understands this may be difficult for schools to host. If there is no solution in securing a location, this event will be changed to a one-day event on Saturday, May 20. Mr. Sirico thanked Goshen for hosting this event on the 20<sup>th</sup>.
- c. Mr. Morse discussed the option of bringing back the Modified Track Meet to 12<sup>th</sup> Rock, which hasn't happened since COVID.
- d. Mr. Semo (Cornwall) inquired about host schools being billed in full for Bowling matches. Mr. Rich Silverstein (Kingston) shared that Kingston's local bowling alley tracks which district each athlete is from at check-in, then the bowling alley bills each school accordingly.
- e. Mr. Coates (Middletown) announced the resignation of Mr. David Franskevicz as the 8-Man Football Representative. Mr. Jason Closs (Tri-Valley) has been appointed to this position.
- f. Mr. Osborne announced that Mr. Mayo will be hosting the Section IX Hospitality Suite at the AAA Conference in March 2023.
