- 3. NYSPHSAA Meeting Review Mr. Greg Ransom/Mr. James Osborne

Mr. Osborne

- a. Budget Dues increase of 1.9% with a 6% increase in expenditures.
- b. Boys Flag Football and Boys Volleyball have been added to the Section IX Sports Dues form.
- c. Unified Bocce will be added to the Section IX Sports Dues form for Fall 2025.
- d. Cut off Numbers Mr. Mayo is recommending a proposal for the Section to present to NYSPHSAA. Establish a timeline for the adoption of classification cut-off numbers for the following school year. Since sections receive cut off numbers from NYSPHSAA for the six classification sports in the fall of the previous school year, it would be prudent for all sports committees to submit proposals for change in the fall of the previous school year to take effect for the following school year. Any changes must be approved, at the

very latest, at the May NYSPHSAA Executive Committee Meeting to take effect in the next school year.
