 Motion to approve minutes made by Mr. Ryan Jasper (Monticello) and seconded by Mr. Joe DiMattina (Florida/Seward). All in favor. Motion carried.
- 2. Coaching License Requirement Ms. Nohemi Munoz

 Ms. Munoz provided a flyer indicating the license requirements, which will also be emailed to
 you for reference and to share with your coaches. She discussed recent changes in the process
 and answered questions. A major change, effective November 1, 2024, is that districts are now
 responsible for being keepers of the course records for First Aid and CPR/AED.
- 3. NYSPHSAA Meeting Review Mr. Greg Ransom/Mr. James Osborne
 - a. Girls Wrestling seeding proposal submitted by Eric Hartmann, Section IX Girls Wrestling Chairperson for the Section IX Tournament. This information was included in the materials for review.

Motion to approve made by Mr. Tim Bult (Minisink) and seconded by Mr. Rich Silverstein (Kingston).

After a discussion, an amended proposal was stated.

Amendment supports using TrackWrestling program as the vehicle for seeding, but only using results from the current interscholastic high school season, and not using any outside matches. If this is not possible to separate out these figures, then use the Boys' method of seeding as the alternative.

Motion to approve the amended proposal made by Mr. Bult (Minisink) and seconded by Mr. Silverstein (Kingston). All in favor. Motion carried.

- Motion to add the following to the NYSPHSAA Handbook:
 Foreign Exchange 9.2. "This Policy Revision only applies to students participating at the Varsity Level"
- > Motion to create a consistent approach to Championship Awards for NYSPHSAA events.
- Motion to continue allowing NYSPHSAA member football programs to start high school football practice on Monday of week#7.
- Motion to allow Section III to start the rotation for the at-large teams in Division I & II in 2025 then establish the remaining rotation after the 2025 Girls/Boys Bowling State Tournament.
- Motion to approve for a set of Super & At-Large Standards for the NYSPHSAA Outdoor Track & Field Championships.
- ➤ Motion to approve a new regional rotation in the sport of Boys Tennis for 2025- 2030 using the guiding principles approved by the Executive Committee.
- ➤ Motion to approve a new at-large rotation to fillbyes for 2026-2030 NYSPHSAA Boys Tennis Team Championship.
- Motion to approve, in Flag Football, to add language to the current rules identifying a minimum belt length. "Flag length is 14 inch minimum from the bottom of the belt (including the clip) to the bottom of the flag as a measuring point."
- Motion to approve changing flag football rule from "The ball is spotted where the ball was when the player is "de-flagged" to "The ball will be spotted where the flag is pulled."
- Motion to change the spot of the ball to the 14 yard line after:
 - The visiting Team will have the choice before the toss-heads or tails
 - The Team who wins the coin toss has the option to defer, select offense (a 20-yard line start). Change to 14-yard line start.
 - After a touchdown, touchback, or safety-any play that results in a team starting at the pr possession line (14-yard line)

Motion to approve made by Mr. Jason Semo (Cornwall) and seconded by Mr. Greg Sirico (Warwick). All in favor. Motion carried.
