The meeting began at 9:39 am.

1. Approval of Minutes from Last Meeting (March 4, 2025)

Motion to approve minutes made by Mr. Jason Semo (Cornwall) and seconded by Mr. Ryan

Jasper (Monticello). All in favor. Motion carried.

2. Section IX Report – Mr. Greg Ransom

- a. Proposal: The Boys and Girls Outdoor Track Committees are seeking approval to waive the NFHS rule for the 2025 State Championships to reduce relay names form 8 to 6. *Motion to approve by Mr. Semo (Cornwall) and seconded by Mr. JJ Gass (Port Jervis). All in favor. Motion carried.*
- b. Indoor track will be revising relay standards.
- c. State Indoor track meets are potentially nearing capacity for fire codes. They may have to make it a two day event.
- d. On the State level, Boys and Girls Tennis want to revise the lineup rules.
- e. Bowling is looking to do an at large rotation.
- f. Volleyball is looking to amend their tiebreaker at the state meet.
- g. Wrestling is looking to change to 14 weight classes.
- h. Both of our Bowling Chairs have resigned. We need volunteers for Boys and Girls Chairs.
- i. Girls Golf wants to change the qualifying standard for Sections. They want a 16 over par instead of 18.
- j. Mr. Ransom asked for opinions on the classification of private and parochial schools to present to the committee. The majority were in favor of the first proposal with the numbers changed.
 - i. The private and parochial schools would have 2 divisions they would play in.
 - ii. The Section III proposal was to do what we do now but instead of the chair deciding where they would go, a state committee would.

- iii. In basketball, those who are AAA would enter the tournament as AAAA. In football, those who are in AA they would play AAA division.
- k. The Big 5 proposal will be presented to the executive committee in May. Both leagues and section have already voted it down.
- 1. Uniform waiver for Volleyball will be a discussion item in May.
- m. Mr. James Osborne said let him know if you need a Section 9 gold card for those retiring.
