Classification of Non-Public & Charter Schools



Proposal for Consideration

This proposal outlines criteria and procedures for NYSPHSAA Section Classification Committees to utilize when evaluating the athletic classifications of non-public and charter school sport programs. It establishes performance-based guidelines for potential movement between classifications, defines processes for incorporating updated enrollment data, and sets forth a clear review timeline aligned with seasonal sports. Additionally, the document details the appeal process available to member schools and Sections to ensure transparency, consistency, and fairness in classification decisions. While providing this standardized framework, the proposal affirms that Sections retain the authority to assign classifications for non-public and charter schools, provided such decisions are made in accordance with consistent criteria and within the established timeline.

1) Criteria for Section Classification Committee

Movement Up in Classification:

Non-Public & Charter school sport programs may be subject to annual reclassification based on performance and enrollment data. A Non-Public or Charter school team may be considered for **movement to a higher classification** if at least one of the following criteria is met:

1. The team achieves a winning percentage of .750 or higher in any of the following categories: overall record, league record, or in-class record (with a minimum of four games played).
2. The team is recognized as a league and/or playoff champion.
3. The team is a sectional semifinalist.
4. The team wins a state championship.

Remain in Current Classification:

A Non-Public or Charter school team may **remain in its current classification** if it meets at least one of the following during the season:

1. a winning percentage of .500 or above in-class, overall regular season, or league competition;
2. the team qualifies for sectionals or wins a first-round sectional game.

Move Down in Classification:

If a non-public or charter school team was previously moved up in classification but does not meet any of the criteria listed above (#1 & #2 of *remain in current classification*), the Section Classification Committee will consider moving the team down one classification level. Any exception to this downward reclassification will require clear, objective justification. However, a team may not be placed in a classification lower than the level determined by its BEDS (*Basic Educational Data System*) number under any circumstances.

Changes in BEDS or Sport Variation Numbers

If updated BEDS numbers or changes to NYSPHSAA sport classification cutoff numbers would result in a non-public or charter school's team moving down a classification, a review of the team's placement may be initiated. The criteria used to justify reconvening the Section classification committee will mirror those required to consider a move up in classification.

2) Examination process

Timeline:

The Section Classification Committee will convene three times a year to review the classification of Non-Public and Charter schools and the dissemination of information.

Fall Sports – Section Classification Committee Meeting in January

*To be reported at February NYSPHSAA Executive Committee meeting

Winter Sports – Section Classification Committee Meeting in April

*To be reported at May NYSPHSAA Executive Committee meeting

Spring Sports – Section Classification Committee Meeting in June

*To be reported at July NYSPHSAA Central Committee meeting

Information to be reviewed:

Relevant information should be submitted to the Section Classification Committee.

1. Sectional tournament brackets, scores and results.
2. Section Transfer information.

Decision to be made for the following school year by the Section Classification Committee.

3) Appeal process

Any NYSPHSAA Section may submit an appeal request to the NYSPHSAA Classification Oversight Committee no less than 15 calendar days following the information being reported to the NYSPHSAA Executive/ Central Committee. Upon receipt of such a request, the Committee will conduct a comprehensive review of all relevant information submitted by both the appealing Section and the Section in which the non-public or charter school is located. Based on the totality of the evidence and circumstances, the Classification Oversight Committee maintains the authority to assign the non-public or charter school to the classification it deems most appropriate.

In instances where a NYSPHSAA member school is directly affected by a decision rendered by its Section's Classification Committee, that school must first exhaust all administrative remedies available to it under its Section's governing documents (e.g., bylaws, constitution, or other applicable policies and procedures). Only after those avenues have been pursued in full may further appeal or review be considered at the state level in accordance with the NYSPHSAA Handbook.

BOYS/GIRLS SWIMMING & DIVING – ADOPT BACKSTROKE STARTING LEDGES STARTING IN FALL OF 2026

Proposal:

The NYSPHSAA Boys and Girls Swimming & Diving Committee is seeking approval to implement NFHS Rule 2-7-3 (this rule can be adopted with State Association approval only). This will allow backstroke starting ledges to be used for high school competition in New York State permitting they meet the guidelines set by NFHS.

Effective:

Fall 2026

Rationale:

This rule would now allow competitors to use backstroke ledges in competition providing the pool meets the minimum of 6' of water depth measured from the starting end through 16'5" from the end wall. It will allow athletes a safer take off from the wall.

Proposal Originated:

At the State Swimming & Diving Committee meetings on May 1, 2025.

Budgetary Impact:

The proposal has been delayed to 2026 so schools have time to purchase the ledges, if necessary. Depending on the facility and who currently uses the facility for practice and meets, the backstroke ledges may need to be purchased. The USA Swimming program and college programs have had the opportunity to use the backstroke ledges for many years and if schools use those facilities, then they will already be equipped with them. If the schools need to purchase, the cost varies from \$75 to \$400 each depending on the brand and style.

Rationale:

Dividing the scoresheet allows for a more accurate implementation of the scoring system, as it enables judges to focus more closely on each scoring element.

Girls Wrestling: Revise the Representation Rule

Proposal:

The NYSPHSAA Girls Wrestling Committee is recommending revising the current NYSPHSAA Representation Rule that allows female wrestlers to participate in both male and female events during the regular season and then chose to participate in the female NYSPSHAA Championship. **The revision would prohibit any female that participates on a boys team during the regular season from participating in the girls post season.**

Effective Start Date:

2026-2027

Rationale:

The committee has supported the current NYSPHSAA Representation language because it allowed Girls Wrestling to grow and gave athletes the opportunity to wrestle. The committee now feels the time has come for girls to choose which post season they are going to participate in by deciding who they will compete against during the regular season. This change would also help in seeding the girl's tournament because all the results would be from girl only matches. The committee believes this proposal helps level the playing field between all female competitors.

The current USA Wrestling rules does not specify a maximum number of matches per day. Typically, girls freestyle matches are much quicker the folk style wrestling matches. Some Sections are having difficulty completing the entire tournament with only being allowed to wrestle a maximum of 6 matches in a day.

Proposal:

The NYSPHSAA Girls Wrestling Committee is recommending adding the following language to the NYSPHSAA Handbook under Girls Wrestling for multi-school meets.

Multi school meet: Minimum of three (3) schools and twenty (15) wrestlers. If the wrestler wrestles only one (1) opponent they are charged one (1) point, if they wrestle more than one opponent, they are charged two (2) points. Each wrestler may only wrestle a maximum of four (4) matches. No team scoring is allowed, and no individual prizes are awarded. Multi-school meets can be attached to dual meets on the same day at the same site. A pound allowance is in effect for matches/tournaments preceding and following a multi-school meet.

Rationale:

The Girls Wrestling Committee believes until teams get bigger and can support having dual meets, this option allows schools to get together and have girls wrestle on the mat during the week instead of waiting to attend a tournament on the weekend.

If they are successful they would keep their challenge but if they are unsuccessful then the opponent would receive one point and the coach would lose the challenge for the remainder of the bout.

Boys Wrestling: Revise Penalty for Cheating on Hydration Test

The NYSPHSAA Boys Wrestling Committee is recommending revising the current penalty for getting caught on the hydration test, which is part of the NYSPHSAA Weight Management Program. The revised penalty would be ineligibility to participate in a match until after January 1st and all post season events.

Boys Wrestling: Revise Penalty for Maximum Number of Tournaments

Proposal:

The NYSPHSAA Boys Wrestling Committee is recommending revising the current penalty for going over the maximum number of tournaments in a season. The revised penalty would mirror the current penalty of going over the maximum number of points/games in a season for all sports.

c. If an individual or team exceeds the maximum number of contests permitted, the penalty is team ineligibility from the date of violation for the rest of the season. In the sports of wrestling, cross country, indoor track & outdoor track, swimming & diving, and bowling, when an individual exceeds the maximum number of contests, only the individual would no longer be eligible for that season. When an athlete exceeds the maximum number of contests the level in which the student-athlete participated as an ineligible competitor will be affected.

Any member school that has exceeded the maximum number of contests has the option to utilize the existing penalty outlined above (c) or may elect to suspend the head coach from all team related functions and activities (including, but not limited to, practices, scrimmages, conditioning/weight training, film sessions, and games) from the date of the violation for the remainder of the season and forfeit additional contests. The use of this option must be submitted to the Section Executive Director and State Executive Director in writing from the Superintendent of Schools or Headmaster self-reporting the violation prior to the next game/contest being played (July 2020)

This proposal provides a consistent penalty to similar situations that may arise by going over the maximum number of tournaments but staying within the maximum number of points during the season.

Boys Wrestling: Penalty for Not Bringing a Track Wrestling Weigh-In Form to a Dual Meet

The NYSPHSAA Boys Wrestling Committee is recommending the following penalty for a team that does not provide a Track Wrestling Weigh-In Sheet at a dual meet.

The team without the Track Wrestling Weigh-In Sheet will forfeit the dual meet. The host school will make every effort to provide the school without the weigh-in sheet to print one.

Effective Start Date:

2026-2027

Rationale:

Wrestling teams are required to use the Track Wrestling Weigh-In Sheet. Schools cannot print out weigh-in sheet unless they have updated their weigh-ins. All teams need to have updated weigh-ins in order for the wrestlers to adhere to the 1.5% weight loss plan. If a team cannot print out the weigh-in sheets the 1/5 % weight loss plan could be manipulated by the coach.

BOYS/GIRLS SWIMMING & DIVING – Establish a Team State Championship

Proposal:

The NYSPHSAA Boys and Girls Swimming & Diving State Committees propose reclassifying swimming and diving from an individual sport to an individual/team sport. This change would introduce a Team State Championship alongside the existing individual championship. Each of the 11 NYSPHSAA sections may send one team, consisting of 8 athletes plus 1 alternate (including divers), to compete on Day 1 of the state tournament. Athletes would compete in their individual events, earning points toward their team's total. The team with the highest points would be crowned the NYSPHSAA Team State Champion, with awards presented to the top four teams.

Note: Most top teams in each section already have athletes participating in the state meet, minimizing the need for additional qualifiers.

Effective Start Date:

2027-2028 school year

Rationale:

The NYSPHSAA Swimming & Diving Committees have long discussed adding a team championship. With stable qualifier numbers at recent state meets, now is an opportune time to implement this change. New York is the only state that does not crown a single-school swimming and diving champion. Aligning with other NYSPHSAA sports, such as girls' golf, this proposal would establish equity by recognizing team achievements. The team championship would enhance competition and engagement, mirroring regular-season dual meets.

Impact on Participation:

The team championship would slightly increase the number of athletes at the state meets while remaining manageable:

- Boys State Meet (2025 Data): 377 participants; with teams, 407–422 athletes (25–40 additional swimmers, 5–6 divers).
- Girls State Meet (2024 Data): 360 participants; with teams, 390–405 athletes (25–40 additional swimmers, 5–6 divers).
- Coaches: No increase in the number of coaches.
- Fans: An estimated 50–150 additional spectators per meet.

Central Committee Meeting – July 29-30, 2025

Each section's team would consist of 9 athletes (8 competitors + 1 alternate), following a format similar to the Girls Golf Team/Individual Championship. Scoring would extend to 16 places for swimming and be based on the order of finish in an 11-dive competition for diving.

Entry Guidelines:

Athletes entered in the individual championship would automatically be entered in the team championship for the same events.

Budgetary Impact:

NYSPHSAA Costs:

- **Awards:**
 - Plaques for 1st–4th place: \$180 per meet.
 - Medals for champion and runner-up teams (9 per team): \$55 per meet.
- **Venue Costs:** Up to \$400 per meet due to extended time (20–30 minutes for swimming, 60–90 minutes for diving on Day 1).

Revenue Offset:

- Additional ticket sales from 50–150 fans at \$10.50 each would generate \$525–\$1,575 per meet.
- Venues (Ithaca, Webster, Erie, and Nassau) can accommodate the increased attendance.

Section/School Costs:

- Minimal travel costs, as most top teams already have athletes at the state meet. The proposal adds 1–6 athletes per section (30–45 total across all sections).



NYSPHSAA
THUNDER & LIGHTNING POLICY

(Effective 10/25/04)
(Revised October 20, 2008)

Applies to regular season through NYSPHSAA Finals:

1) Thunder and lightning necessitates that contests be suspended. The occurrence of thunder and/or lightning is not subject to interpretation or discussion - thunder is thunder, lightning is lightning.

a) With your site administrator, set up a plan for shelter prior to the start of any contest.

2) When thunder is heard and/or when lightning is seen, the following procedures should be adhered to:

- a) Suspend play and direct participants to go to shelter, a building normally occupied by the public or if a building is unavailable, participants should go inside a vehicle with a solid metal top (e.g. bus, van, car).
- b) Do not permit people to stand under or near a tree; and have all stay away from poles, antennas, towers and underground watering systems.
- c) After thunder and/or lightning have left the area, wait 30 minutes after the last boom is heard or strike is seen before resuming play or competition.



HEAT INDEX PROCEDURES

Administration of Heat Index Procedures:

- Feels Like Temperature (Heat index) or THI using a Wet Bulb indicator on the field will be checked 1 hour before the contest/practice by a certified athletic trainer, athletic director, or school designee when the air temperature is 80 degrees (Fahrenheit) or higher.
- Download WeatherBug app to your phone or log into www.weatherbug.com. Schools may also use a Wet Bulb indicator on the field that will be used.
- Enter zip code or city and state in the location section of the app or on-line or determine the THI by using a Wet Bulb indicator.
- If the Feels Like temperature (heat index) or the Wet Bulb Indicator is 90 degrees or above, the athletic trainer, athletic director, or school designee must re-check the Feels Like temperature (heat index) or Wet Bulb indicator at halftime or midway point of the contest. If the Feels Like temperature (heat index) or Wet Bulb indicator is 96 degrees (Fahrenheit) or more, the contest will be suspended.

WIND CHILL PROCEDURES

Administration of Wind Chill Procedures:

- Feels Like Temperature (Wind Chill) will be checked 1 hour before the contest/practice by a certified athletic trainer, athletic director, or school designee when the air temperature is 39 degrees (Fahrenheit) or lower.
- Download WeatherBug app to your phone or log into www.weatherbug.com.
- Enter zip code or city and state in the location section of the app or on-line.
- If the Feels Like temperature (wind chill) is 10 degrees or below, the athletic trainer, athletic director, or school designee must re-check the Feels Like (wind chill) at halftime or midway point of the contest. If the Feels Like (wind chill) temperature is -11 degrees (Fahrenheit) or lower, the contest will be suspended.

Please refer to the following chart to take the appropriate actions:

Tornado Policy

- Tornado Watch-indicates tornados are possible. Event staff must continue to monitor the situation.
- Tornado Warning-Tornado siren sounds signaling tornado sighted or tornado indicated by radar

GUIDELINES/PROCEDURES

- If a tornado warning is initiated, immediate event delay shall be implemented, and all participants, spectators and athletic staff shall seek shelter immediately. Once inside a secure location, tune to local weather alert radio to be informed of the storm location, path and duration of tornado warning.
- Warning may be extended, or a new warning issued at any time, so continue to monitor.
- Safe shelter from tornado inside lowest building level, away from exterior walls/windows, with windows closed.

All Clear-tornado warning will expire after duration specified by the National Weather Service and the site director will notify all involved that the warning has ended, and the event may resume.

New York State Public High School Athletic Association Drone Policy

The New York State Public High School Athletic Association prohibits the use or possession of unmanned aircraft or aerial systems (UAS), also known as drones, for any purpose by any person or entity at all scrimmages, regular season and post season events.

This prohibition applies to the area above and upon all spectator areas, fields of play, courts, arenas, stadiums, mats, gymnasiums, pools, practice facilities, parking areas and or other property being utilized for the purpose of the interscholastic activity.

If there is a report of UAS activity at an athletic event school, Section and/or State Association officials will, in consultation with the sports officials, suspend the play until such time as the UAS is removed from the area as defined above or the school, Section/ State and sports officials determine it is safe to proceed.

For purposes of this policy, a UAS is any unmanned airborne device or aircraft. The NYSPHSAA, Section and/or Member School reserves the right to refuse admission to anyone operating or attempting to operate a UAS or to request the immediate removal of any person using or attempting to use a UAS in violation of this policy.

The NYSPHSAA Executive Director has the authority to grant an exception to this policy to law enforcement, public safety agencies, NYSPHSAA media partners, or other entities or individuals. Any request for an exception to the policy must be submitted to the Executive Director at least a week prior to the event. The exception is limited to the specific event requested and requires the consent of the host venue.

Any use granted under this provision must comply with the applicable FAA regulations as well as any and all requirements set forth by NYSPHSAA. News media must have the necessary FAA authorization. Any individuals granted an exception would be required to sign a document acknowledging and agreeing to the terms of use and agreeing to hold the NYSPHSAA and its member schools harmless from damage to persons or property.

SECTION IX

Unsportsmanlike Conduct Rule

Sportsmanship: The NYSPHSAA and Section IX recognizes and appreciates that the influence and responsibility of the school administration with regard to good sportsmanship extends to all levels of competition. However, it must also be seen that the NYSPHSAA AND Section IX has been vested with the responsibility to ensure that all contests under its jurisdiction are conducted satisfactorily. This standard applies to all regular season and post schedule play.

As of July 1, 2013, the Dignity for All Students Act (Dignity Act-Section 52.2, Part 80 and 57-4) is to provide all public-school students with an environment free from harassment, bullying (including cyber bullying) and discrimination, as well as to foster civility in public schools. The Dignity Act focuses on the prevention of discrimination behaviors, including harassment/bullying through the promotion of educational measures meant to positively impact school culture and climate, which includes the interscholastic programs.

Use of derogatory or racially explicit language; discriminatory harassment or bias conduct that creates a hostile environment that is disruptive to the educational environment. Spectators shall not be permitted to use vulgar/offensive or racially/culturally insensitive language or engage in any racially/culturally insensitive action. NYSPHSAA Sections may sanction, censure or place schools on probation that fail to address derogatory or inappropriate behavior deemed harmful to physical or mental well-being for those involved in interscholastic activities. (July 2023)

I. **Coach (There is no appeal to a coach ejection. The official's decision is final). (Please refer to the NYSPHSAA Handbook – Sportsmanship; Standard 28):**

1. Any coach excluded by a certified official from an interschool competition for unsportsmanlike conduct is ineligible to coach any interschool competition in that sport until after the next previously scheduled contest at the same level (e.g. junior varsity, varsity, etc.) has been completed. Disqualification from one season carries over to the next season of participation. **The coach may not be present at the game site** nor communicate in any manner during the contest with any person present at the site. **NOTE:** “Not being physically present at the site” means the disqualified coach is not to be present in the locker room, on the sidelines, in the stands or site area before, during or after the game/meet.

Any coach that does not serve the penalty for violating the Sportsmanship Standard will be ineligible to participate in the next two regularly scheduled contests. If the coach continues to not serve the penalty, the matter will be referred to the Section for further action. If the coach is involved in the NYSPHSAA play-offs, the matter will be referred to the Executive Director of the NYSPHSAA.

Any coach:

- A. Who receives a disqualification penalty in a sport shall not participate in the next regularly scheduled contest;
- B. Who receives a second disqualification penalty in the same sport in the same season shall not participate in the next two regularly scheduled contests;
- C. Who receives a third disqualification penalty in the same sport in the same season will not be allowed to participate for the rest of the season (regular season or post schedule play), the Section Athletic Council will assess the penalty carrying over into the next season of participation.

D. The Section IX Athletic Council will have the authority to extend the period of ineligibility in those cases where the actions of the individual that was disqualified from a contest or scrimmage are warranted. The period of ineligibility cannot exceed one year from the date of the disqualification.

2. A coach who strikes, shoves, kicks or makes other physical contact with the intent to do so to another person (e.g. official, another coach, player, fan) shall be expelled immediately and banned from further participation or coaching in all sports for one year from the date of the offense.
3. The coach that was ejected will notify his/her Athletic Director of the incident on the same day that it occurred. The Athletic Director will then contact the League Coordinator as the coach(s) will not be allowed to participate in the school's next scheduled game/games as above.

4. **Player Ejections: (There is no appeal to a player ejection. The official's decision is final).**

1. Any member of a squad ruled out of a contest for unsportsmanlike conduct (flagrant foul, two technical fouls in basketball, two yellow cards, red card, inappropriate language or taunting, fighting, etc.), the following action is **required** by the NYSPHSAA Regulations detailed in Standard #28:

- A. First Ejection – that player(s) cannot attend or participate in the next scheduled contest **in that sport**. If the season has ended the player(s) cannot attend or participate in the next scheduled contest in his/her next season of participation. **NOTE:** In the sport of football, a player who is disqualified for “targeting” (by a certified official) may not participate in the next two halves. **(May 2022)**
- B. Second Ejection – that player(s) cannot attend or participate in the next two scheduled contests **in that sport**. If the season has ended the player(s) cannot attend or participate in the next two scheduled contests in his/her next season of participation.
- C. Third Ejection – that player(s) cannot attend or participate in any remaining scheduled contests for the remainder of that sports season – including sectional, regional and state contests. If the season has ended the player(s) cannot attend or participate in the next three scheduled contests in his/her next season of participation.
- D. The Section IX Athletic Council will have the authority to extend the period of ineligibility in those cases where the actions of the individual that was disqualified from a contest or scrimmage are warranted. The period of ineligibility cannot exceed one year from the date of the disqualification.

• ***For the sport of Football only:***

Any member of a squad ruled out of a contest for unsportsmanlike conduct or for a flagrant foul will have the following occur:

- A. **First Ejection** – that player(s) cannot participate in the next two (2) consecutive halves in that sport. If the season has ended the player(s) cannot attend or participate in the next scheduled contest in his/her next season of participation.
- B. **Second Ejection** – that player(s) cannot participate in the next four (4) consecutive halves in that sport. If the season has ended the player(s) cannot attend or participate in the next two scheduled contests in his/her next season of participation.
- C. **Third Ejection** – that player(s) cannot attend or participate in any remaining scheduled contests for the remainder of that sports season. If the season has ended the player(s) cannot attend or participate in the next three scheduled contests in his/her next season of participation.

Please note: Disqualifications from one season will carry over to the next season of participation.

5. Any member of the squad who strikes, shoves, kicks or makes other physical contact with the intent to do so to an official shall be expelled from the game immediately and banned from further participation in all sports for one year from the date of the offense. **NOTE:** "Member of the squad" includes player, manager, scorekeeper, timers, and statisticians.

A. Communication Responsibilities regarding ejections:

1. The official who ejected the player(s) or coach shall notify the League Coordinator prior to 12:00 Noon the following day of the name(s) of the player(s) or the coach and the infraction(s). The League Coordinator shall notify the Athletic Director of the offending school.

2. The coach of the player(s) who was/were ejected will notify his/her Athletic Administrator by 12 noon the following day. The Athletic Administrator must report the ejection to their respective League Coordinator by 12 noon the following day.

6. **Misidentified Player:** Disqualification of a player may only be challenged on the basis of misidentification. The misidentification must be established by clear and concise evidence. The school shall identify the offending player who will serve the prescribed penalty. (**Dec. 2010**)

II. Official:

1. Unprofessional conduct on the part of official such as, but not limited to, taunting, baiting, use of profanity, shall be reported by a school administrator from the aggrieved school to the Section Executive Director. A request will be made to the appropriate sport officials' chapter to investigate the incident and to report their action to the Section in a timely manner.

Spectator Policy at Athletic Contests:

1. **Expectation Statement:** Officials, just like student athletes and coaches, are critical to interscholastic sports programs. Without officials, NYSPHSAA and its member schools would not be able to provide interscholastic sports in the manner that is desired and expected by student athletes, coaches, and parents. Spectators are expected to "Be Loud, Be Proud, and Be Positive." Negative comments and inappropriate behaviors by spectators are required to be addressed by all and any school supervisors and administrators, as a member of NYSPHSAA. Spectators may be prohibited from attending current and future interscholastic contests based on their behavior. (Oct. 2022)

2. **Spectator Regulation:** Any negative, inappropriate, derogatory comments or actions that draw the direct attention of a supervisor or school administrator by a spectator or group of spectators are required to be addressed by the host school, Sectional or NYSPHSAA representative in the following non-sequential order depending on the comments or behavior:

- First warning – Directing the spectator or group of spectators to refrain from any negative comments or actions.
- Second warning – A personal discussion with the spectators or group of spectators on the above NYSPHSAA expectations and reminding the spectators or group of spectators of the next step, removal of the game or event, will be utilized if the behavior continues.
- Removal from the contest – The spectator or group of spectators will be directed to leave the facility for the remainder of the game or event. If spectators or group of spectators refuse to leave the game or event, play will be stopped until they vacate the premise.

Penalty for being removed from a game or event:

Any spectator removed from a game or event **will have a minimum penalty of completing the NFHS Parent Credential course or a one game suspension before they are allowed to attend any interscholastic event.** Once the course is completed the spectator will provide a certificate of completion to the athletic department office. Schools are required to communicate with the offending spectator on the NYSPHSAA Sportsmanship Spectator Expectations.

- Depending on the severity of the behavior/comments or future disqualifications by the offending spectator NYSPHSAA and the Section may get directly involved in the situation. **(May 2023)**

Spectator Code of Conduct

Section IX Athletics recognizes the importance of behavior and personal character in our student athletes. As such, we ask our spectators to:

1. Demonstrate a high degree of sportsmanship.
2. Show team support by making only positive comments.
3. Show respect for the judgment of coaches, officials, and referees.
4. Acknowledge fields, courts and equipment as the player's domain during contests.
5. Monitor the safety of children in the bleachers and stands.
6. Respect the law. All public schools and Section IX venues are smoke-free, substance free environment.
7. Athletic contests home, away or at a neutral site are an extension of the classroom. Therefore, all school rules are in effect.
8. Spectators will respect and obey all school officials, supervisors and site personnel at contests.
9. There will be no ringing of bells, sounding of horns, or other noise makers at indoor contests.* Outdoor use will be at the discretion of the site personnel.

*This does not apply to spirit groups including school approved pep bands or cheerleaders.

10. The throwing of debris, confetti, or other objects from the stands is prohibited. Offending individuals will be asked to leave the premises.
11. Exceptions to this behavior will lead to ejection from the event.

Please note that individual schools may have more stringent policies.

Spectator Policy at Athletic Contests:

1. Expectation Statement: Officials, just like student athletes and coaches, are critical to interscholastic sports programs. Without officials, NYSPHSAA and its member schools would not be able to provide interscholastic sports in the manner that is desired and expected by student athletes, coaches, and parents. Spectators are expected to “Be Loud, Be Proud, and Be Positive.” Negative comments and inappropriate behaviors by spectators are required to be addressed by all and any school supervisors and administrators, as a member of NYSPHSAA. Spectators may be prohibited from attending current and future interscholastic contests based on their behavior. (Oct. 2022)

2. Spectator Regulation: Any negative, inappropriate, derogatory comments or actions that draw the direct attention of a supervisor or school administrator by a spectator or group of spectators are required to be addressed by the host school, Sectional or NYSPHSAA representative in the following non-sequential order depending on the comments or behavior:

- First warning – Directing the spectator or group of spectators to refrain from any negative comments or actions.
- Second warning – A personal discussion with the spectators or group of spectators on the above NYSPHSAA expectations and reminding the spectators or group of spectators of the next step, removal of the game or event, will be utilized if the behavior continues.
- Removal from the contest – The spectator or group of spectators will be directed to leave the facility for the remainder of the game or event. If spectators or group of spectators refuse to leave the game or event, play will be stopped until they vacate the premise.

Penalty for being removed from a game or event:

Any spectator removed from a game or event **will have a minimum penalty of completing the NFHS Parent Credential course or a one game suspension before they are allowed to attend any interscholastic event.** Once the course is completed the spectator will provide a certificate of completion to the athletic department office. Schools are required to communicate with the offending spectator on the NYSPHSAA Sportsmanship Spectator Expectations.

- Depending on the severity of the behavior/comments or future disqualifications by the offending spectator NYSPHSAA and the Section may get directly involved in the situation. (May 2023)

Permission for Special Accommodations

Every situation requesting permission for special accommodations (including religious apparel) is evaluated on an individual basis.

The procedure is as follows:

SPECIAL DEVICES AND PROSTHESIS

1. Written approval by the school physician to participate in a specific sport while wearing the device.
2. Review of the NYSPHSAA approved sport specific rules to determine if there is a prohibition.
3. The member school requests, in writing from the Athletic Director on school stationery, a review and evaluation by the Assistant Director responsible for safety. All requests are to be accompanied by photos of the device being worn by the student taken from several different angles. Additionally, documentation of school physician approval is to be sent.
4. NYSPHSAA review consists of reviewing the game rules, evaluating if the student would be safe participating while wearing the device, evaluating if teammates and opponents are placed at risk, and possible consultation with our medical advisors.

RELIGIOUS ACCOMMODATIONS

1. Review of the NYSPHSAA approved sport specific rules to determine if there is a prohibition.
2. For a special accommodation the member school requests, in writing, a review and evaluation by the Assistant Director responsible for safety.
3. Written explanation of the special accommodation needed from the student's religious leader.
4. NYSPHSAA review consists of reviewing the game rules, evaluating if the student would be safe participating while wearing the device, evaluating if teammates and opponents are placed at risk, and possible consultation with our medical advisors.

SPECIAL ACCOMMODATION

1. Review of the NYSPHSAA approved sport specific rules to determine if there is a prohibition.
2. The member school requests, in writing, a review and evaluation by Assistant Director responsible for safety.
3. Written documentation from school physician outlining the student's physical limitations and need for a special accommodation.
4. NYSPHSAA review consists of reviewing the game rules, evaluating if the student would be safe participating while wearing the device, evaluating if teammates and opponents are placed at risk, and possible consultation with our medical advisors.

The NYSPHSAA will provide written notice of approval or denial to the school district in a timely manner.

31. TRANSFER:

(Foreign Exchange/International #9)

NOTE: The Transfer Rule will be enforced as written with no variations permitted.

NOTE: A student's eligibility is determined by the situation/ facts at the time of registration.

a. A student in grades 9-12 who transfers, with a corresponding change in residence of his/her parents (or other persons with whom the student has resided for at least six months) shall become eligible after starting regular attendance in the second school. A residence change must involve a move from one school district to another. Furthermore, when a student moves from public school district to another public-school district for athletic eligibility the student must enroll in the public school district or in a private school within that district's boundaries of his/her parent's residency. For athletic eligibility, a residency is changed when one is abandoned by the immediate family and another residency is established through action and intent. Residency requires one's physical presence as an inhabitant and the intent to remain indefinitely. The Superintendent, or designee, will determine if the student has met district residency requirements.

b. A student who transfers without a corresponding change in residence of his/her parents (or other persons with whom the student has resided for at least six months prior) is ineligible to participate at the varsity level in any interscholastic athletic contest in a particular sport for a period of one (1) year if as a 9-12 student participated in that sport during the one (1) year period immediately preceding his/her transfer. A student's period of ineligibility begins with the date of registration at the student's new school. (May 2020) **NOTE:** Students in grades 7-10, shall be eligible to participate at the sub-varsity level and practice at all levels, while students in grades 11-12 shall be limited to practice (all levels) only. (July 2019). At no time during the one-year period of ineligibility at the varsity level should a student participate in a scrimmage or be an exhibition participant at the varsity level.

Students who transfer from any school to the public-school district of the residence of his/her parents (or other persons whom the student has resided for at least six months) or a private school within that district's boundaries shall receive a waiver from the Transfer Rule. Such a transfer without penalty will only be permitted once in a high school career. **Schools must submit the required transfer form to the Section office. Athletes are not permitted to practice before the form has been submitted. Athletes are not permitted to compete without approval.** **NOTE:** A student in a foreign exchange program listed by CSIET has a one-year waiver of the Transfer Rule. If such a student elects to stay a second year he/she becomes a foreign student at the start of the school year with item (b) in effect.

Exemptions to (b): For athletic eligibility, a student must enroll in the public-school district or in a nonpublic school within that district's boundaries of his/her parent's residency. **NOTE:** Multiple High School Districts - The policies/boundaries of the school district will be followed. If the district has an open enrollment policy, the interpretation to be used will be the same as used for students of K-8 school districts. When a student enrolls in 9th grade, this is the district (building) of their residence. Any subsequent transfer would be subject to the Transfer Rule.

1. The student reaches the age of majority and established residency in a district and can substantiate that they are independent and self-supporting.

2. If a private or parochial school ceases to operate a student may transfer to another private or parochial school of his/her choice. Otherwise, a student must enroll in the public-school district of his/her parents' residency.

3. A student who is a ward of the court or state and is placed in a district by court order. Guardianship does not fulfill this requirement.

4. A student from divorced or "legally" separated parents who moves into a new school district with one of the aforementioned parents. Such a transfer is allowed once every six months. The legal separation agreement must address custody, child support, spouses support and distribution of assets and be filed with the County Clerk or issued by a Judge.

5. A student who is declared homeless by the superintendent pursuant to Commissioner's Regulation 100.2.

6. A student of a military employee who is transferred to an active military base may enroll in the non-public school closest to their residence and maintain eligibility if the student enrolls in a non-public school immediately following the change in residence.

NOTE: It is provided, however, that each school shall have the opportunity to petition the section involved to approve transfer without penalty based on an undue hardship for the student. Educational Waivers will not be considered as an undue hardship.

c. Transfer students trying out for sports before school opens in the fall shall register and be accepted by the principal of that school before the medical examination and the first practice. This shall constitute the start of the regular attendance for falls sports. **NOTE:** After approval by the school medical officer a student may practice immediately and must satisfy the specific sports standard according to the number of practice sessions.

d. Practices at the previous school may be counted toward the minimum number of practices required provided the principal or athletic director of the previous school submits, in writing, the number and dates of such practices to the principal or athletic director of the new school.

e. 7th and 8th graders that compete at the high school level will be subject to the transfer rule in "that" sport (July 2015).

Transfer Appeal Guidelines: Financial - Appeals require documented proof of a significant loss of income or a significant increase in expenses. - Written description outlining the circumstances that led to the financial hardship - Appropriate documentation may include: - Evidence of loss income or change in financial obligation that are not self-imposed. - Family W2 forms - pay stubs - Notarized statement from parent - Statement from employer or professional with knowledge of circumstances - Most recent tax returns - two years Health and Safety - Appeals are considered for safety, mental health, personal relationships and other similar circumstances. - Written documentation is required from Superintendent of Schools or High School Principal of the sending school indicating the specific circumstances which necessitated the transfer. - Supporting documentation from a third party outside of the school may be submitted (ex. police report)

Transfer – NYSPHSAA

- Your school's guidance department should notify you that there is a new student in the district and fill out the Transfer Student Information form.
- If you are satisfied that the student transferred into the district meeting the criteria in Standard 30a. or that the student did not participate in a particular sport during the one (1) year period immediately proceeding his/her transfer (standard 30b.) or that the student meets one of the six exemptions to (b) and that student meets all other Eligibility Standards, you may determine the student is eligible.
- If you determine that the student does not meet the above criteria for Standard 31, you must fill out the Request for Waiver of NYSPHSAA Standard #31 – Transfer. Please mail or fax to Tom Cassata, Chairperson.
 1. Upon receipt of this request (page one only) Section IX will grant a waiver of the transfer rule for any student athlete transferring to his/her public school district of residency or a private school within that district's boundaries from any school. The waiver will be granted only one time per athlete.
 2. Upon receipt of this request (page one only) Section IX will grant a waiver of the transfer rule for any student who will play at the JV level only for one year from the date of transfer.
 3. If this form is to request a transfer without penalty based on an undue hardship for the student (Standard 31b. – Note: be sure to attach all three pages and supporting material documenting the undue hardship. The Eligibility Committee will render a decision at the next Section IX meeting.

REMINDER: TO ALL CONCERNED

The transfer rule is still in effect and without a waiver an athlete for which the rule applies remains ineligible. Schools using ineligible athletes are subject to the forfeit penalty, which cannot be made retroactive. Athletic Directors are urged to set up a system to track all transfer students.

Duration of Competition Extensions (Standard 8i)

Review NYSPHSAA Standard 8. Duration of Competition.

Review the details with the student and parent(s) and obtain documentation that the pupil's failure to enter competition during one or more seasons of a sport was caused by illness, accident, or similar circumstances beyond the control of the student (Standard 8i). Determine that the student meets other Eligibility Standards (age etc.)

Fill out Duration of Competition Extension Application (Standard 8i) and attach supporting material and documentation. Please mail or fax to Thomas Cassata, Chairman. The Eligibility Committee will render a decision at the next Section IX meeting.
