Transition Plan: Returning to RSchool Activity Scheduler

Background

For the past several years, we have utilized **RSchool Today Activity Scheduler** as our primary scheduling and communication platform. This system has served both our **League/Section administration** and **Athletic Directors** effectively.

Recently, RSchool was purchased by **PlayOn Sports**, who subsequently sold the platform to **Arbiter** — a long-established company known primarily for its **officials' assigning and payment system**.

At the conclusion of the previous school year, Arbiter informed us that we would be transitioning from the RSchool Activity Scheduler to their own scheduling software. RSchool was officially **shut down at the end of June**, and Arbiter assured us that their new system would be operational by **August 1**.

Current Situation

While Arbiter's team has been working diligently, the current functionality of their platform **does not yet meet the needs** of our schools, leagues, and administrative structure.

Following in-depth discussions with Arbiter's **Vice President**, it was mutually agreed that we would **temporarily return to the RSchool platform** for the remainder of the current school year. This will allow Arbiter additional time to continue developing and refining their system to meet our requirements.

Rationale for Returning to RSchool

After evaluating our current position and the needs of our schools, we determined that returning to RSchool provides the most stable and functional platform at this time.

This transition will:

- Ensure continuity and reliability for scheduling and communication.
- Allow Arbiter sufficient time to **customize and optimize** their software for our specific needs.
- Prepare for a **smooth relaunch with Arbiter** in **July 2026** for the **2026–2027 school year**.

Transition Plan and Key Steps

1. Transition Back to RSchool

- Bring plan to Athletic Directors for approval
- Begin preparations immediately following the **end of the Fall season (late October)**.
- Provide schools with **access to RSchool** to begin preparing winter schedules.

2. Communication and Public Awareness

- Launch a **marketing campaign** to promote the **Activity Scheduler App** through:
 - Social media platforms

- School and Section websites
- Venue signage and event materials
- Distribute **Activity Scheduler promotional signage** to schools for public display.

3. Training and Support

- Provide **training and video tutorials** for:
 - Athletic Directors
 - Coaches
 - Secretaries and administrative staff
- Offer ongoing support during the transition to ensure smooth adoption.

Transition Timeline

July 2026	Arbiter relaunch and marketing campaign	Official transition for 2026–2027 year

The decision to return to **RSchool Today Activity Scheduler** is a proactive measure designed to ensure stability and effectiveness for our schools, officials, and communities. This transition will allow Arbiter to continue refining their platform while we maintain a reliable system for day-to-day operations.

Through clear communication, training, and public awareness efforts, we will ensure a smooth transition back to RSchool this fall and a successful reimplementation of Arbiter in **July 2026**.
