Current Protocol

***Covid-19 Positive Case within the Family Unit When Not Fully Vaccinated:**

The 14-day quarantine period starts for all other family members on the day after the person with COVID-19 completes their isolation period (usually 10 days from the day their symptoms started, or if they did not have symptoms, 10 days from the day they got tested). Refer to If You Are Sick: How Long to Stay Home www.health.state.mn.us/diseases/coronavirus/sick.html#stayhome.

Adopt Additional Alternative Protocol

Option #2 - PreK-Grade 6

A student may take a COVID-19 test on days 11-14 following a positive case within the family unit (usually 10 days from the day their symptoms started, or if they did not have symptoms, 10 days from the day they got tested). With a negative Covid-19 test, the student may return on Day 15 and will be required to wear a mask through Day 24. They must remain symptom free during this time frame. Additionally, all members of the homeroom class of said student will also need to wear masks during the same period.

- Isolating from the positive within family unit from the day of symptoms or positive test result is strongly encouraged as much as possible.
- Isolation practices include masking, using different bathrooms or keeping the positive on a different level of the residence.

Adopt Additional Alternative Protocol

Option #1 – Grades 7-12

A student may take a COVID-19 test on days 11-14 following a positive case within the family unit (usually 10 days from the day their symptoms started, or if they did not have symptoms, 10 days from the day they got tested). With a negative Covid-19 test, the student may return on Day 15 and will be required to wear a mask through Day 24. They must remain symptom free during this time frame.

- Isolating from the positive within family unit from the day of symptoms or positive test result is strongly encouraged as much as possible.
- Isolation practices include masking, using different bathrooms or keeping the positive on a different level of the residence.
