After fall screenings are completed, students are identified who are not reading at or above grade level and a form goes home to parents requesting reading intervention services through either or ADSIS program or Reading Corps. Students are then progress monitored and parents are notified if students demonstrated that they are ready to exit the program. We use the same process for winter screening. Spring screening and MCA scores help identify which students qualify for summer targeted services based on not reading at or above grade level in which a letter is sent home to parents requesting specific students to come in for additional services. All parents are notified about effective reading practices and strategies to encourage at-home reading. In the past, we have hosted literacy nights and it is our intent to get back to doing this again.

At the elementary level, our district follows an MTSS framework. Once students are identified as being at-risk (below grade level), they are given four diagnostic assessments that determines their main deficit area. Listed below are the key interventions used by ADSIS/intervention reading staff:

- PA: Sound Detective Kit (Auditory Level), Phonemic Alphabet Story Writing
- Phonics: Sound Detective Kit (Phonics Level), Phonemic Alphabet First Readers w/ Word Building, Beginning Reads w/ Sentence Building
- Fluency: Guided Oral ReReading, ROAR (Repeated Oral Assisted Reading)
- Vocabulary: Slash and Dash, Spot and Dot, Spelling by Pattern
- Comprehension: ReQuest (Questioning Strategy), Reading Power (Fiction and Nonfiction), Reciprocal Teaching

Progress monitoring occurs on all qualifying ADSIS students on a bi-weekly basis. Reading staff discuss student progress regularly and make modifications to the reading intervention as needed. Reading intervention through the ADSIS department is considered to be Tier 2 or 3 depending if individual or small group.

FastBridge universal screening occurs three times a year in fall, winter, and spring. At these times, data is examined to determine which students qualify for reading intervention, need possible modifications, or have met exit criteria.

Wabasha-Kellogg staff are enrolled in the CORE Online Language and Literacy Academy starting June 2024 with the goal to complete one model a month and be finished by May 2025. Teachers have been given resources to work at their own pace while also be provided time to collaborate with each other in this learning process. The goal is to implement consistent, research based practices across the district. Administration is also being trained so we can identify if these practices are in place while doing walk-throughs and evaluation. We will determine if these practices are effective based on meeting or exceeding our school literacy goals.

We need consistent implementation of Tier 1 resources. We have identified primary and ancillary resources in our curriculum that follows a scope and sequence throughout the district. We have areas that we can improve in the upper grade levels starting in 5th grade by either purchasing and extending the series we currently use in grades K-4 (Wonders) or to purchase curriculum that has been approved through the READ Act (Wit and Wisdom).

Best practice Reading instruction will also be a priority for PLCs throughout the school year as we establish goals and the check teacher progress on attaining those goals periodically.
