Mr. King informed the board that the junior class took the ACT test last week, which was held in the city auditorium, and informed them that the MCA testing is in progress at the high school. Ms. Allen shared with the board that she felt making up the extra snow days in June will not have much of an impact for students and learning.

WHEREAS, said recommendations have been received and considered by the School Board;

BE IT RESOLVED, by the School Board of Independent School District No. 299, as follows:

That the following programs and positions or portions thereof, be discontinued:

- 1. Instructional Coach Licensed Position 1.00 FTE
- 2. Agriculture Teacher 1.00 FTE

The motion for the adoption of the foregoing resolution was duly seconded by Member Jared Barnes and upon vote being taken thereon, the following voted in favor thereof: Jared Barnes, Melissa Marschall, Emily McGonigle, Kelley McGraw, Wendy Woyczik, and Spencer Yohe. The following voted against: Matt Blocker. Whereupon said resolution was declared passed and adopted by a 6/1 vote.

ADMINISTRATIVE REPORTS

Mrs. Meinertz informed the board that the elementary just completed I Love to Read Month and thanked her staff for all their hard work into this fun program for the students. The elementary students held a penny war and raised almost \$2,000, which will be donated to HEART. The Kwik Trip Milk Moola program has been discontinued. The elementary building had a successful Showcase evening with great attendance. The elementary students are working on raising money to start a yoga club. She informed the board that we are in the process of updating recess equipment for the students. She updated the board regarding the curriculum committee and stated this committee will be meeting on Tuesday. MCA testing is happening in the elementary building.

Mrs. Morem thanked her staff for doing a great job during the testing season. She congratulated the Robotics team for advancing to the World's Competition. MCA testing has begun. The middle and high school students practiced a tornado drill. Teacher interviews will be held on April 25th. She informed the board that student enrollment continues to increase for the 2019-2020 school year.

Mrs. Runningen was absent. In her report she submitted to the board, she informed the board that she is working on the community ed summer flyer. She continues to accept registrations for the Hand-in-Hand Preschool, School Readiness/Early Childhood Family Education, and SAC/Surround Care programs. She is working on the plans for the summer SAC program. She updated the board regarding testing. The ADSIS application was submitted, and our school district requested \$704,090.18 in funding. She is working on end of the year reports. The school district was approved for two Minnesota Reading Corp members for the 2019-2020 school year. The Summer Vista volunteer positions are still open.

Superintendent Ihrke stated that a lot of options were discussed at the February 26, 2019, special school board meeting as it related to the weather related make-up days for the 2018-2019 school year. He congratulated the Robotics team for qualifying for Worlds. He thanked all the staff for all the extra work during testing season. He thanked Mr. Morem for all the work he has been doing during the recent storm damage from last week Thursday. The Extended School Year Calendar Committee has met and will continue to work on a balanced school year calendar.

Mrs. Meyer attended the IEA health and safety quarterly meeting. She attended the Region V Spring Conference in Austin. She continues to work with Mr. Ihrke and Mr. Morem on the boiler project and the ten-year long-term facility maintenance plan. She is working with Mrs. Runningen on the ADSIS budget and codes. She is working on gathering bus route information and transportation for homeless students, working on revenue and expenditure budgets for 2019-2020, working with Dependable Solutions to get MSA client communicating with PowerSchool again after several changes, reviewing website vendor options with Superintendent Ihrke, and working with the school district insurance company after the storm damage and power outage.

NEW BUSINESS ITEMS

The high school graduation ceremony will be held on Friday, May 31st at 8:00 p.m. and Directors Emily McGonigle and Spencer Yohe will assist in handing out diplomas at the graduation ceremony.

BOARD MEMBER REPORTS

Director Yohe updated the board regarding the MSBA State Capitol session and the Minnesota State High School League meeting he attended. Superintendent Ihrke informed the board that he will update the board on the HVED progress during the regular board meeting in May. Directors Woyczik and McGonigle attended the extended school year calendar committee meeting, which is a work in progress as it relates to building a balanced school year calendar. Director McGonigle shared with the board information from the meet and confer committee meeting she attended. Superintendent Ihrke informed the board that the snow day relief language that the legislation passed is permissive for school districts and not all schools are taking advantage of this bill.
