Setting of Special School Board Meeting to Canvass November 6, 2018, Election Results

Moved by Emily McGonigle, seconded by Melissa Marschall to hold a special school board meeting on Friday, November 9, 2018, at 5:00 p.m. in the superintendent's office to canvass the November 6, 2018, election results. Motion carried by a unanimous vote.

ADMINISTRATIVE REPORTS

Mrs. Meinertz updated the board regarding the new teacher cohort. She informed the board that the Beaver Creek State Park day was moved to the fairgrounds due to the rain and cold temperatures. The students enjoyed stations from Myrick Park, the library, the historical society, Beaver Creek staff, and the Mississippi Archaeology Center. The first volunteer day was held for the natural playground, and another day is planned for October 27th. Circle of Security trainings continue with paraprofessionals. She participated in the MESPA Leadership to guide professional development at the state level and is also the president-elect for our division this school year. She updated the board regarding personalized professional development.

Mrs. Morem shared with the board the results from the senior interviews. She informed the board that the career fair for the students was a very successful day. Teachers have created great smart goals. PLC leaders are doing a fantastic job keeping all moving in a positive direction. Middle school has been finishing up their Lion's Peace posters and Patriot's Pen Essay.

Mrs. Runningen was absent. In her report she submitted, she updated the board regarding Hand in Hand Preschool and ECFE. She informed the board that enrollment numbers in the afternoon class has increased to 17 students. They continue to have students register for the SAC and Surround Care Programs. The community education fall classes and trips catalog has been distributed. The Caledonia Balloon Rally will be held the weekend of October 20th, and community education staff will be participating in activities for children during the Wild Turkey Fest that will be held the same weekend. She updated the board regarding the Caledonia Interact Group and will be planning food drives throughout the community and schools to benefit the Caledonia Food Shelf as part of their participation in iFeed 2018 that will be held on November 3rd. Interact and Rotary will have a team that will help pack 100,000 bags of food to go to Nicaragua. She updated the board regarding testing.

Superintendent Ihrke informed the board that he attended the Great Start Cohort the end of September. Caledonia Are Public Schools was not selected as one of the lottery winners for the School Safety Grant. If the storm water fee with the City of Caledonia is enacted, this could cost the school district an approximate \$7,000 for the year, which has not been budgeted for. Prior to completing the sale of the garage and property on Sprague Street, the school district needs to complete a compliance checklist, and his is hopeful that this can get completed by the end of October. The fall sports season is coming to an end, and he thanked all the coaches, athletes, and fans for their efforts and support during the fall season.
