ADMINISTRATIVE REPORTS

Mrs. Meinertz updated the board with regard to curriculum work. The committee is discussing graduation requirements, accountability for online courses, and AP versus College in the Schools. The staff development plans for teachers for January 25th have been finalized. She informed the board that a whole-school celebration for being one of the twenty schools named as a Reward School will be held on January 22nd at 2:00 p.m. The student achievement leadership team created a plan for next year's assessment days. There will be two days with half hour assessment blocks for students and teachers. During that time, parents will go to the media center for presentations on Standards-Based Grading, Schoology, and E-registration. Hearing and vision screening will also take place on the same day. The Climate and Culture team is writing lesson plans for implementing ALICE in the classrooms. A school-wide book study on how to effectively implement PLC's has been started.

Mrs. Morem informed the board that the district Spelling Bee will be held on January 27th at 9:30 a.m. Mrs. Field Rohrer's class will be participating in a writing contest "My Favorite Teacher" through Barne's and Noble. Middle school continues to work on PBIS rewards. She also is looking for the board's thoughts on requiring music in grades 6 – 8. Seniors have ordered items for graduation. The Dorian Music Festival was held on Monday. Speakers have been coming on Mondays to share their careers with students. Athletic teams have played some tough competition this past month and have done well. One-Act Play competition was held this past weekend. The Robotics program continues to prepare for their competition. The band concert will be held on February 2nd for grades 9 through 12.

Televisions have been installed in both middle and high school hallways. Warrior WOW awards have been given to students. The Parent FASA meeting will be held on January 20th at 7:00 p.m.

Mrs. Runningen was absent.

Superintendent Barton informed the board that he is continuing to work with Barb on the One Day Bond budget and hopes to have this ready to present to them at the February board meeting.

Mrs. Meyer informed the board that the Safe Routes to School Grant has been submitted. She continues to work with the staff on time-study data, year-end reports, and other business office items.

Mr. Jerviss is working on a five year technology plan with the Technology Committee. He has created a One Day Bond list for the technology department. He informed the board that the school district has received 60% Erate funding to replace all our network switches in the district. Our portion would be \$17,665 and Erate would pay \$24,585. He continues to work on a lot of the daily things with iPads, projectors, smart boards, speakers, laptops, desktops, printers and many other items in the district.
