The board discussed this idea and requested that more information be gathered like the costs for this program and if there would be enough student participation to warrant this. Mr. DeMorett updated the board regarding the current BCLO Program and that he is still working on an application process so that our school district can be our own site for this type of program.

Mrs. Runningen updated the board on the community education fall classes being offered. She stated that there will be two Junior First Lego League teams registered for students ages 6-9. A parent meeting will be held on October 7th for this. The ECFE teacher and ECFE parent educator positions are still open, and she will be discussing staffing options with the Minnesota Department of Education. She updated the board regarding testing and grants. She will be attending the ECFE/School Readiness Coordinator State meeting on October 7th.

Superintendent Barton and Directors Jared Barnes, Kelley McGraw, and Spencer Yohe met with the Houston School District to start conversations on areas our school district and their school district can possibly have shared services in both course offerings and administration. They felt it was a very positive experience with exciting opportunities and will keep the board apprised of any future decisions or meetings that will be held.
