ADMINISTRATIVE REPORTS

Mr. DeMorett asked the board to starting thinking about graduation and who would like to hand out diplomas during the ceremony. State testing will be held this week Tuesday and Wednesday at the middle/high school. He is working with Simoine Bolin on an ALP Application that if approved would eliminate the costs of students going to Hokah BCLC as they would stay in our school district. The staff and administration continue to work on the ADSIS grant application that is due April 25th.

Mrs. Runningen updated the board regarding testing. She is working on the final budget revisions for the Title Grant. The school district received a Wellness Grant from the Southeast Service Cooperative in the amount of \$1,850 for funds to be used to equip staff wellness rooms and for wellness incentives. She is in the process of hiring students to work in the SAC program and filling the preschool teacher vacancy.

Mr. Barton personally acknowledged Joanne Zard for her years of service and wished her well as she retires from the school and also thanked Dave Meyer for the great job he has done as the athletic director for the school district. He also informed the board that they will need to look at how they want to fill the athletic director position. The Qcomp revisions have been submitted and are waiting to hear back from the state to see if our school district has been approved. He updated the board regarding the principal and teacher evaluation process. He informed the board that a decision will need to be made on how the school district would like to implement the Professional Learning Communities (PLC's) into the school days for the teachers beginning the 2013-2014 school year.
