#### **ADMINISTRATIVE REPORTS**

Mr. Doty distributed to the board information that will be presented to students and parents the night of the Middle School Orientation on Tuesday, August 29<sup>th</sup>. He informed the board that he is attending the HVED Reading Training Workshop in Winona this week.

Mr. Helmers distributed to the board information about how the staff development monies are being utilized for staff throughout the school district. He stated that there are seasonal athletic meetings with Mr. VanDenBoom, the coaches, and himself held in the fall, winter, and spring. The fall meeting will be held next week. The board requested that all coaches be given an Athletic Handbook.

Mr. Moriarty shared with the board information he received from the Houston County Department of Transportation with regard to the underpass estimate located along Highway 44/76. They informed Mr. Moriarty that this underpass would cost more than \$175,000 of the grant money from the State of Minnesota. He updated the board with information he received from Michael's Engineering regarding the energy analysis at the middle/high school building. It was the consensus of the board to have Michael's Engineering do a presentation at the September 18<sup>th</sup> board meeting. He informed the board that the audit is near completion and that it will be presented to the board either at the September or October school board meeting.

Mrs. Runningen updated the board regarding the building facility usage. She is continuing to work on the Community Education Staff Manual and the Fall/Winter catalogue. She attended the Adult Basic Education Summer Institute in August and will be meeting with the ABE teachers on August 24<sup>th</sup>. The SAC Program currently has 35 students registered for the 2006-2007 school year.

Mrs. Busta discussed with the board the annual report for the Early Childhood Family Education (ECFE) and School Readiness Programs.

Director Schulte informed the board that the middle/high school signage is progressing and that there are no school dollars being spent on this project.
