2023-2024 Resolution for Membership in the Minnesota State High School League

Member Spencer Yohe introduced the following resolution and moved its adoption:

RESOLVED, that the Governing Board of School District No. 299, County of Houston, State of Minnesota delegates the control, supervision and regulation of interscholastic athletic and fine arts events (referred to in MN Statues, Section 128C.01) to the Minnesota State High School League, and so hereby certifies to the State Commissioner of Education as provided for by Minnesota Statues.

FURTHER RESOLVED, that the Caledonia Area Middle/High School is authorized by this, the Governing Board of said school district or school to renew its membership in the Minnesota State High School League; and, participate in the approved interscholastic activities and athletics sponsored by said League and its various subdivisions.

FURTHER RESOLVED, that this Governing Board or entity hereby adopts the Constitution, Bylaws, Rules and Regulations of said League and all amendments thereto as the same as are published in the latest edition of the League's Official Handbook, on file at the office of the school district or as appears on the League's website, as the minimum standards governing participation in said Leaguesponsored activities. Further, the administration and responsibility for determining student eligibility and for the supervision of such activities and athletics are assigned to the official representatives identified by the Governing Board or entity.

Signing this Resolution for Membership affirms that this Governing Board has viewed all the required membership materials provided by the League which defines the purpose and value of education-based activity and athletic and programs and defines each member school's responsibilities.

Member schools must develop and publicize administrative procedures to address eligibility suspensions related to Student Code of Responsibilities (Bylaw 206.2) violations for students participating in activity and athletic programs by member schools.

ADMINISTRATIVE REPORTS

Mrs. Link informed the board that our patrol picnic was held on Friday, May 5th. We are most fortunate to have had so many safety patrol volunteers this year. Thank you to Ms. Howe who has worked with our school patrol throughout the years on top of her many other duties. Thanks also to our parent chaperones and custodian, Brandon Jones who helped with our picnic. The Caledonia Senior High School Band played for the 3rd-5th graders on Monday, May 8th. Under the direction of Mr. Moburg, the band gave an extraordinary performance. These band members have impressive talent. The Elementary Spring concert was held on May 11th. Mrs. Myhre led the students in many uplifting songs that also had lyrics of patriotism, sunshine (our theme this year), and character. Great job Mrs. Myhre and students! On May 12th, the Eitzen fire department provided a fire truck ride to school for four elementary students. This was purchased at the 299 Foundation Fun night. Thank you for supporting our school. Grandparents/Special Friends Day took place on Friday, May 12th. We enjoy seeing our parents, grandparents, and special friends. Grandparents impact our children's lives more than they may know. On May 18th, we will have our "Wax Museum" and Science Fair. It takes much effort and time for both the teachers and the students, but the outcome is worth it. The elementary will be having a "Field Day" outside on May 19th with activities for all ages. If there is inclement weather, we will have a back-up plan. On May 25th, there will be an awards ceremony for grades K-5 in the gym at 9 AM. Several awards will be presented to students for the accomplishments and contributions that they have made throughout the year. We are having a 5th grade promotion on May 25th at 10 AM in the elementary school gym. Parents, grandparents, friends, and community members are invited to attend. Thank you to Mrs. Engan, Mr. Hebeisen, Mrs. Myhre and all who helped to put this together. All of the teacher observations have been completed. We have fantastic instruction and learning going on in our classrooms. Report cards will be going home with our students on the last day of school, Thursday, May 25th. Thank you to Colette Bruening for her 40 years of service at Caledonia Area Elementary School. Her experience, knowledge and caring will be greatly missed. We wish her well in her next endeavors. This is our last board meeting before the end of the school year, so I would like to give my sincere thanks to everyone. We could not have made it through the year without helping each other along the way. Thank you to our board members, entire staff (teachers, paraprofessionals, counselors, school nurses, custodians, bus drivers, cooks, coaches, office staff) PACE, (elementary parent group) volunteers, students, parents and community members. It truly takes a village to educate and support our children!

Mr. Boler informed the board that the last month has been another month of wrapping up the 2022-2023 school year. There is a great deal of planning which goes into the end of the year with MCA testing, graduation, device return, and many other end of the year tasks. Planning continues for the 2023-2024 school year. Some changes needed to be made to the master schedule as hiring continues. There is a chance of additional changes based on other changes that may be coming. At present, this

includes the hiring of a 6th grade teacher as that teacher moved to a new position internally. On May 2nd, the 8th grade students attended a Career Exploration Fair at MN College Southeast. This provided all 8th graders with hands-on demonstrations. By the end of the day Monday, May 15th, all state mandated drills will be complete. He has completed all teaching observations and will be wrapping up all post evaluations with staff in the coming week. MCA testing has been completed. At present, the results are unofficial. Overall, we saw improvement in our scores. There is always room for growth and improvement. We have a number of educational field trips planned for the last couple weeks of school. The 7th graders will be attending Eagle Bluff May 17-19th. The 6th graders will be traveling to the cities on May 18th. 9th grade orientation was held on May 5th. A big thank you to Brent Schroeder for taking the lead on this. Congratulations to our FFA members who competed at the State FFA Convention April 23-25th. Congratulations to our BPA students who competed at Nationals April 26-28th. Congratulations to all students who participated in activities throughout the school year. Best of luck to spring activities as they complete their respective seasons in the coming months. Some of the meetings I have attended include but are not limited to: administration meetings, SE MN principal meetings, Crisis Committee, Activities Committee, MTSS Committee, Honor Society, HS Student Council, PBIS, Sprague Woods Committee, Staff Meetings, BCC Meeting, IEP meetings, & Q-Comp.

Mrs. Juan informed the board that we are still taking registrations for our 3K and 4K programs. The 4K preschool classes are planning a field trip to Eitzen park on May 19th. Kindergarten Academy will be held on June 1st through June 8th. We received grant money from the state to fund this. SAC staff training was held on May 10th so we are ready for summer. T-ball/Peewee will start on June 5th. She will be attending the Region 1 Community Ed Director's meeting on May 19th. Community Ed Advisory Committee meeting will be held on May 16th at 6:30 p.m. in the MSHS Media Center and will be discussing the Fall 2023 catalog. All MCA testing is complete. She updated the board regarding the CPAS Care program informing them that we are fully staff for the summer. We have two staff having knee surgery this summer so have hired staff to cover for them. The last day of school will be the last day that preschool is part of the daycare license. Starting this summer, the preschool will operate as it had in previous years. This allows more flexibility for staffing, training, etc., and we are looking forward to this change. Preschool aged students will attend SAC if care is needed before and after school. Surround Care will be our transition room for children who age out of the toddler room, but who do not make the cutoff for starting preschool.

Superintendent Ihrke publicly thanked Colette Bruening for her forty years of service and dedication to our school district and wished her all the best as she will be missed! He updated the board in regards to the HVED Superintendent's Advisory Council meeting that he attended. He stated that MCA testing is now complete, and the preliminary results show improvement. The Elementary Reading and Math scores look particularly amazing. High School Science scores also increased by a great deal. He also informed the board that staff recognition will be held Tuesday of this week at 3:30 p.m. and high school graduation will be held on May 26th.

Barb Meyer participated in the following meetings: the Health and Safety Committee meeting, Merchants Bank meeting, MDE Staff Development meeting, and SSC meeting on financial analysis and forecasting utilizing MDE data. Continues to work on paperwork regarding grants. Free Breakfast and Lunch for 2023-2024 (MDE unsure if that includes preschool). She is working on credit card processing set up and participates in various other meetings with departments. Other business office duties (invoicing, claiming, billing, reconciling, etc.)
