#### III. Work Session- New Business

#### A. Activities guidance and plans

Jeremy Childress discussed how coaches are keeping social distancing rules in place during practice and leading into games. A screening process is done every morning before practice by using a checklist of questions and taking temperatures. They have rules in place for the locker room, water breaks and have removed school issued towels based on state guidance. They will try and take an additional bus for away games and will require masks on the bus. They will also allow students to ride with parents. Mr. Jiskoot reported sport guidelines and spectator sports guidance is changing almost daily. Concession stand food is now allowable but will have to continue to monitor what is allowable at the time of the event.

#### B. NFHS cameras and online viewing

Jeremy Childress discussed a new option for streaming events on YouTube. West Lyon received a gaming sports grant that needs to be used for sports and deemed COVID related. Childress discussed that the NFHS network has a lot of technology that runs itself so a person wouldn't have to perform the setup and manage the filming. One camera would go in the main gym and one on the football field. This would also allow any or all events to be streamed in those locations. There would be a fee to watch events. \$7.99 month, \$9.99 a season or \$70 for a year. This would encompass all events on the NFHS network, not just West Lyon's. Several schools in the conference are currently using this feature. Everything that would be outside of those two locations in the old gym would be streamed like it is today. Events will stream as normal until the new system is set up.

### C. Return to Learn updates

Supt. Kreman spoke on the fluid changes to guidelines from the state, Department of Education and Department of Health. He highlighted that local districts have some control, but are still trying to follow guidelines as much as possible. Guidelines and recommendations will continue to be monitored on a daily basis leading up to the start of school and beyond to meet the needs for West Lyon students, staff and families. An updated Return to Learn plan will be available to parents and the district by August 12th.
