Motion # 2770

Moved by Jenson and seconded by Bauder to approve the agenda with the addition of discussion on Staffing Models. Motion carried, all members voting "yes".

Principal Jiskoot presented exhibits on a proposed Attendance Policy/Semester Test Exemption Policy change. Jiskoot said he had shared the proposed changes with the SIAC, his Teacher Advisory Group, and his Student Council. No Action was taken. A decision on the possible changes could be made by February or March.

Superintendent Kreman headed discussion on facility needs. Kreman reported on the results of a facility survey that was shared with the public. He also said he headed a Community Forum, on the same topic, during Parent-Teacher conference. Board members said they would like to do some more fact finding by meeting with people about building needs. Another Work Session was set for January 20th to continue work on the subject.

Principal Jiskoot presented information on staffing needs for next year along with historical class enrollment information. Jiskoot told the Board that he needs additional staff in some curricular areas and less in others. No action was taken,
