Approve the Agenda

A motion was made by Member Peterson, seconded by Member Lehnertz, and carried unanimously to approve the agenda.

OLD BUSINESS

Accept the Parking Lot Seal Coating Quote

Purchasing Committee Member Todd Peterson advised that two quotes had been received: Burton Asphalt at \$18,125 and M&M Construction, Inc. at \$36,125. Supt. Carolan and Chair Pagel had each checked the reputation of Burton Asphalt and had found no complaints.
